#### Michigan to get \$61M to remove lead pipe

WASHINGTON, D.C. Michigan will receive more than \$61 million from the Environmental Protection Agency (EPA) to help communities identify and replace an estimated 203,670 lead service lines that are in use in Michigan.

An announcement made May 2 by U.S. Sens. Gary Peters and Debbie Stabenow said the money would be made available from the EPA's Drinking Water State Revolving Fund, which is funded by the bipartisan infrastructure law the senators helped enact. Nationwide, the EPA announced \$3 billion in investments for states, tribes and territories through the same fund. "Every American deserves access to clean and safe drinking water," said Peters. "Thanks to the bipartisan infrastructure law I helped pass, we are making critical investments to replace lead service lines, helping to protect Michiganders from lead exposure."

In Flint, the epicenter of a water poisoning scandal and the resulting lead service line replacement, a court settlement called for the excavation of water service lines in about 31,500 homes, and replacement where lead and galvanized pipes were found. As of March, only about 275 homes still had lead service lines, for various reasons, including homeowners refusing the service.

Editor DEARBORN – Ford Motor Co. has been keeping building trades workers very busy in recent years.

Soon, front and center in the public's eyes will be the completed work on the gloriously renovated Michigan Central train station, due to open to

data, as a long era of budget cuts and dangerous state policies combined to imperil the ability of the Occupational Safety and Health Administration to protect America's workers.

Changing jobs can be the best way to get a raise. But employers often force workers to sign "non-compete clauses," making it harder for them to move to better jobs – and artificially depressing wages.

That will change later this year. The Federal Trade Commission recently issued a new rule declaring that most noncompete clauses in employment contracts are unfair.

The new rule bans employers from requiring workers to sign these agreements and prohibits the enforcement of existing "non-competes" for workers other than senior executives.

This is an important step toward fostering fair competition and empowering workers. Non-compete agreements are employment provisions that ban workers at one company from working for, or starting, a competing business within a certain period of time after leaving a job. They're ubiquitous. The Economic Policy Institute finds that more than one out of every four private-sector workers are required to sign one as a condition of employment.

These agreements aren't limited to high-wage workers in knowledge-sensitive occupations and industries. More than a quarter (29 percent) of private workplaces with an average wage of less than \$13 per hour used noncompete agreements for all their workers, according to one survey.

The only leverage non-union workers have with their employers is their ability to quit and take a job somewhere else. But employers have been using noncompete agreements to cut that source of worker power off at the knees.

Non-competes are about reducing competition, full stop. It's in their name.

Total U.S. construction spending dipped 0.2 percent from March to April, the Bureau of Labor Statistics announced May 1, but remained 9.6 percent above the March 2023 level. And a nice 6.1 percent jump in April in the Dodge Momentum Index for

### 'Quite a life' for century-old 498 electrician, D-Day vet

'There aren't very many like Sam who are still with us'

TRAVERSE CITY - Here's a tip of the hard hat to Sam Bossingham.

The member of the Greatest Generation is a World War II veteran and D-Day survivor, a founding member of IBEW Local 498, a past electrical supervisor on numerous major construction projects in northwest Michigan, a parent of six children, and a new centenarian.

"It's been quite a life, but God has been looking out for me," he said.

Bossingham, 100, was honored as an IBEW Local 498 charter member on April 27 at the union's 75th anniversary celebration at the Hagerty Center in Traverse City. Along with four other electricians, he participated in founding the local union in 1949, after serving his country as an Army sergeant in World War II.

# Michigan's rare pair of pro-worker wins recognized by UA

When your organization plays a key role in getting your state's right-to-work law rescinded – and then in the same month helps get your state's prevailing wage law reinstated – maybe that deserves some recognition.

Both of those momentous events happened in the same month, March 2023, and were made possible by a thin majority of Democrat pro-worker law-

makers in Lansing, prompted by lobbying of numerous unions and union associations. One of them was the Michigan Pipe Trades Association, which was recognized last month for its role in lobbying to restore prevailing wage in the state, and removing the state's right-to-work law.

Both were rare, historic wins for the labor movement, and caught the attention of the United Association of Plumbers, Pipe Fitters and Sprinkler Fitters.

National UA leaders recognized the historic wins for working people in Michigan – only one state has ever rescinded its rightto-work law, and bringing back a statewide prevailing wage law is also exceedingly rare.

### Seriously: CEOs vs. NLRB

Elon Musk, CEO of SpaceX and Tesla, Jeff Bezos, chairman of Amazon, and Bryan Palbaum, CEO of Trader Joe's all have been trying to stop workers from unionizing at their companies. Now Musk, Bezos, and Palbaum have something else in common. Their companies are arguing that the agency that enforces our nation's labor laws can't protect workers' rights to organize because it is unconstitutional.

That agency - the National Labor Relations Board - has filed numerous charges against Musk's, Bezos', and Palbaum's companies for violating workers' rights to organize. Rather than allow their employees to freely organize for better working conditions and wages, they have chosen to threaten these democratic values and practices.

Billionaires attacking political and economic democracy has ramped up over the years. Since the mid-2010s, billionaires have spent hundreds of millions of dollars ensuring right-wing judges are appointed to the Supreme Court and lower federal courts. These same judges took a sledgehammer to democracy, declaring that corporations are people, giving billionaire CEOs a First Amendment right to buy U.S. elections.

They also cut the heart out of the Voting Rights Act of 1965, allowing states to pass laws squarely aimed at disenfranchising Black and brown voters. And add insult to injury, they decided that gerrymandering - drawing district lines that allow the right-wing to win a majority in Congress even when people vote against them was just fine.

Despite their efforts to rig democratic systems from every angle, CEOs haven't been able to fully realize political domination. In fact, a majority of Americans have repeatedly rejected the unbridled capitalism they are trying to achieve. Even now, they don't have majority support for such aims, no matter how hard they try to buy votes.

Even now, they don't have majority support for such aims, no matter how hard they try to buy votes.

CEOs' direct attempts to diminish political democracy have been simultaneously executed with their attacks on economic democracy. The same allies on the Supreme Court that have been dismantling political democracy have been striking blows against people trying to practice democracy at work, including taking a union away from home healthcare workers, attempting to weaken public sector unions, and letting employers sue striking workers for hurting their profits.

The latest attack is a more frontal assault. The agency that enforces the law protecting workers when they organize has become much more active during the Biden Administration, holding more CEOs and big corporations accountable. At the same time, union favorability is at a high point.

Under normal circumstances, we could laugh off such an attempt to eliminate the NLRB. Courts have long ruled that such independent agencies are perfectly legal and have decided thousands of appeals of NLRB decisions without considering that the agency itself is not constitutional. However, in the current world in which CEOs routinely bribe right-wing Supreme Court justices and those justices strike down rights that everyone has considered settled for generations, there is every reason to take their attack seriously.

"Our plan calls for significant infrastructure modifications, literally rebuilding our product campus from the underground up - all while maintaining operations."

The Central Campus Building is expected to be complete next year and "co-locate more than 6,000 Ford employees mainly designers and vehicle development teams," the company said. Henry Ford was nearly unparalleled for big thinking. He built massive automotive manufacturing plants, he acquired rubber-making works and purchased vast tracts of forest to provide automotive raw materials, he built iron ore freighters and rebuilt railroads to move those goods, and he even erected entire communities so Ford workers could have decent housing.

But Henry was notoriously a man of contradictions - perhaps due to his humble early life on a farm in Springwells Township, he always claimed a kinship with farmers, small towns and the working man. He focused not only on making the Model T affordable and reliable, but also on manufacturing vehicles like tractors, whose engines could not only be used to power the plowing of fields but to generate domestic electricity for farmhouses.

Ford will forever be associated with massive construction projects, among them the Ford-**Rouge plant – which for decades** was the world's largest manufacturing facility. But in Michigan, anyway, Ford had a significant impact on the landscape of a number of far-flung communities where he built supplier facilities. And of those plants, a common theme was that he constructed them near a river or tributary to take advantage of the efficiencies of hydro power. Many of them are still in place, repurposed for modern usage and seen as an asset to their community.

The Henry Ford said "in the early 1920s, Henry Ford

said Beyond the Model T. Thomas Edison laid the cornerstone of the hydroelectric plant at Ford's home in Dearborn in 1915.

Ford appreciated the efficiency of hydroelectric power on both small and larger scales, and his acquisitions didn't always stay within Michigan's borders. Two of the largest hydroelectric sites he obtained were purchased from the U.S. government. These were dams on the Hudson River near Troy, New York, and on the Mississippi River at Minneapolis-St. Paul.

One of Ford's largest hydro works in Michigan was the Ford Lake Dam on the Huron River, built in 1931-32. According to a history provided by Ypsilanti Twp., the current owner of the site, "the Ford Lake Dam and powerhouse was built in the **1930s by Henry Ford to supply** electricity to the Ypsilanti Ford Motor Plant" where automotive electrical components were made. "In 1969, the Ford Motor Co. gifted the dam and powerhouse along with about 1,000 acres of land to the City and Township of Ypsilanti." Today the powerhouse produces about 1.1 megawatts of electricity. Ford himself said of his hydro plants: "It is this sort of productive industry that I am going to link up closely to the farm, to demonstrate the final stage of what I believe to be the solution of the problem of living. Manufacturing, instead of being concentrated in a few centers, should be and can be widely distributed. We have proved that we do not have to turn out a completed product in our central plant. We used to assemble all our cars here in Detroit; we found it more economical to build great assembling plants in many other parts of the country and of the world, and ship the finished parts." Ford spread out his parts manufacturing in southeast and south-central Michigan, building new or improving the hydro sites. The first was in Northville, a grist mill that Ford converted into a valve manufacturing site in 1919. Ford also developed sites in Brooklyn (horn buttons, starter switches), Dundee (copper parts), Clarkston (drill bushings, straps, seat covers), Flat Rock (vehicle lamps), Milan (soybean processing), Manchester (ammeters, gauges, and

instrument clusters), Nankin Mills in Westland (screws, then engravings and stencils), and Saline (soybean processing), just to name a few.

Stretching the meaning and the boundaries of a village industry - just a bit - Ford also had large, extensive works in the Upper Peninsula, to take advantage of the wood resources available there that could be made into Model T parts. Construction on the Ford Dam Site in Iron Mountain on the Menominee River began in 1923 and was completed the next year. It would power a large sawmill works, using electricity generated from three turbines (11,000 horsepower) at a hydro plant on the river, combined with a coal-fired power plant. The sawmill, long-gone, employed more than 7,000 at its peak in 1925.

prevailing wage and fringe benefit requirements to be deposited into the bill's proposed Prevailing Wage Fund. It also would require LEO to create and maintain a certified payroll database for contractors and subcontractors to submit certified payroll records that contained specific information."

The registration system would use payroll databases to track the number of daily hours worked, the start and end time of each workday, the hourly wage rate, overtime wage rate and hourly fringe benefit rate of each applicant's construction mechanic.

The bill also gets specific on the types of solar and wind projects that would require prevailing wage, seemingly closing loopholes for contractors who may try avoiding to avoid the law. For example, the proposed law specifies that solar installations must be two megawatts or more, and that prevailing wage must be paid for when it comes to construction of access roads, feeder lines, footings, and a host of jobs related to the solar installation.

The prevailing wage bill also applies both to publicly and privately financed wind and solar projects - and removing the private projects from the reach of the law drew unsuccessful amendments from Republican lawmakers.

"Why are you so afraid of the free market?" asked state Sen. Thomas Albert (R-Lowell). He said prevailing wage would "artificially raise costs of wind and solar projects in Michigan, and those costs would be passed along to families and businesses through their higher utility bills."

Sen. Jeff Irwin (D-Ann Arbor) responded that there is "nothing artificial about how those paychecks end up putting food on the table for them and their families. And there's also nothing artificial about how when you get quality work done by well trained and well-organized people that you get better projects and that these projects last longer.

"They serve the people better. And after all, that's why we're here, to serve the people. So when we pay a fair wage for a good job, I don't see anything artificial about that. I see that as delivering on the bottom line to our taxpayers."

Born in South Dakota, and moving with his family to northwest Michigan before the war, Sam was drafted into the Army at age 18. He was assigned to the 81st Chemical Battalion, which was part of the fourth or fifth wave of the amphibious D-Day assault on Germanheld positions on the Normandy coast in France. "It was awful," he said of his experience on Omaha beach, "I was incredibly lucky that I didn't get hit. Four other units to the right of us got the hell beat out of them.

After breaking through the German beachhead at Normandy, Bossingham said he and his fellow soldiers had to deal with the notorious "hedgerows" - tall hedges that hampered movement and provided cover for German defenders. Bossingham said they tossed hand grenades over the hedges before they attempted to move forward.

His unit moved through various small French towns, liberating them. During a surprise attack from a German-held farmhouse, Bossingham said an "88" anti-tank artillery shell whistled through the wheels of a wagon that was providing cover for two men his unit, but it didn't explode. A good friend of his wasn't so lucky, he was killed by a German sniper.

Bossingham said his unit was recognized with a citation for continued service under 120 days of continuous hostile fire. His unit, he said, lost far more men fighting in Belgium than on D-Day. "I lost a lot of guys who I was in training camp with," he said. Their unit fought in Pointe Du Hoc, Normandy and Northern France, the Ardennes Forest in Belgium and the Rhineland, among others.

He said they didn't see much action during the Battle of the Bulge, but he did have two notable run-ins with famed Third Army commander, Gen. George Patton. Near the Allied front, Patton ordered two large tanks to be brought up on flatbed trailers along an autobahn, and Bossingham said he was part of the delivery crew, but they could only move at night in order to avoid being strafed by German planes. They also had to wait for a path to be cleared around a destroyed bridge, but finally delivered the tanks after a day-and-a-half journey. "What the hell took you so long?" Patton demanded when the tanks arrived, as Bossingham recalled.

In another memorable meet-up with Patton during the Battle of the Bulge, Bossingham said he witnessed Patton personally directing Allied jeeps, tanks and personnel carriers. "He was a real character, cussing and swearing," Bossingham said. "But he was a helluva soldier. With him, there was no such word as 'can't.""

Having survived the war, Bossingham went back home in Interlochen. In 1947 Sam met his wife Anna, to whom he was married for 72 years until her passing in 2018. They had three boys and three girls.

Sam said there wasn't a lot of work available, but took an arduous job of "moving cement." Not liking that too much, he answered an employment ad in the Traverse City Record Eagle seeking tradesmen, and he soon was on the path of becoming an electrician after passing an exam.

Bossingham said two electricians from Detroit Local 58 moved to the region and urged the formation of a new IBEW local union based in Traverse City. He was one of five electricians who undertook the process of starting a union in 1949, and for a while, he said their "union hall" was at one end of a local bar.

The union really took off with the construction of a new paper mill in Manistee, which employed about 50 electricians. Bringing them in as union members "really got us above water," Bossingham said.

Bossingham went on to work and then act as superintendent on major projects like the new Big Rock Nuclear Plant in Charlevoix, five new school jobs in the region, an addition to Frankfort's hospital and a tuberculosis hospital addition at Munson Hospital in Traverse City. "I worked for a lot of contractors, they would call me when they needed somebody for a major project," Bossingham said. "Today there are probably some people who remember me, but a lot of them are gone." He retired from the trade in 1983.

At the April 27 party, Bossingham said "he never shook so many peoples' hands," while talking to today's Local 498ers about his service in World War II and in their union's history.

"I'm really proud of my service in the war, and I'm also proud of he role I had in starting the union; you bet I am," Bossingham sa

began locating small hydroelectrically powered plants in rural southeast Michigan. These 'Village Industries' employed local people who could maintain farms while working at the factory."

According to the book Beyond the Model T – The Other Ventures of Henry Ford by Ford R. Bryan, Ford "began acquiring and building a series of more than 30 hydroelectric plants ranging from 22 to 18,000 h.p.

"According to Roscoe Smith, who managed the Ford hydroelectric plants for many years, Henry Ford preferred to restore old mill sites for his small plants rather than pick new sites. He wanted to preserve their historic appearance as much as possible. If there was not enough water-power to meet his production plans at that location, he would add auxiliary steam power. Often the neat and sparkling little steam engine - always plainly visible within the showcase windows – added as much charm as the waterwheel."

Ford's interest in hydro power began when he and his father visited Coon's Mill on the Rouge River, where corn and wheat were ground. In 1915, when Henry and his wife Clara moved into their newly built Fair Lane Estate in Dearborn next to the Rouge River, they "hired celebrated landscape architect Jens Jensen to camouflage the hydroelectric dam that powered Fair Lane,"

est power development on the Menominee River at the time," wrote William J. Cummings of the Menominee Range Historical Foundation. The still-operating hydro plant continues to pump out 7,200 kilowatts for owner We Energies.

A great number of Ford's village industry sites have been repurposed and modernized for use as offices, manufacturing, or public gathering space. And a number of the sites have been listed on the National Register of Historic Places.

Henry Ford's pioneering development of automotive engineering and sales, developing manufacturing assembly lines, plant construction, worker pay levels, use of the five-day workweek and a whole list of other industry accomplishments is unparalleled in American history. Of course, he also has detractors for his antipathy toward unions, antisemitism, attempts at social engineering, autocratic tendencies and mixed environmental record.

And while dams and hydro works built a century ago can have mixed reviews for their impact on the landscape a century later - especially when dams fail - Ford's village industry works were, by design, generally modest and low impact, and are today a valued part of many communities in Michigan.

"His service and experience in the war, and then around here as the only living charter member. People at our party were waiting to shake his hand. There aren't very many like Sam who are still with us."

### Construction economy sails along, shrugging off obstacles and uncertainty

(Continued from Page 1) tick down in the latter half of 2024, more substantive growth in nonresidential planning activity should follow.'

The Associated General Contractors reported May 3 that the U.S. construction industry added 9,000 jobs in April – the fewest since August 2022 - as a downturn among residential remodelers and subcontractors undercut job gains at nonresidential construction firms. On a yearover-year basis, industry employment increased by 258,000 jobs, a jump of 3.2 percent. The AGC said demand for workers remains high among nonresidential firms, but residential specialty trade contractors – firms that work on home remodeling and renovation as well as new constructionshed 1,100 employees.

"It appears that high interest rates are dragging down remodeling, homebuilding, and apartment construction," said Ken Simonson, the AGC's chief economist. "But firms working on infrastructure, data centers, renewable energy, and manufacturing projects are continuing to add workers and would like to hire more." U.S. construction employment in April totaled 8.21

million workers.

The AGC said the ongoing shortage of construction workers is "likely making for longer project completion times and holding down monthly spending on private projects."

The construction industry unemployment rate fell to 5.2 percent in April, with overall U.S. unemployment rising from 3.8 percent in March to 3.9 in April. Overall April hiring rose by 175,000 jobs - not bad, but below expectations,

"It is really quite remarkable that the nation's nonresidential construction sector continues to add jobs so consistently in an environment characterized by elevated project financing costs," said ABC Chief Economist Anirban Basu. "At the heart of growing demand for construction workers in America is the prevalence of megaprojects in many parts of the country, including major manufacturing plants, data centers and public works.

"Based on ABC's Construction Confidence Index, there is more hiring to come," said Basu.

## **Snubbing OSHA impacts** construction fatality rates

rate, the most recent data available, at 3.7 deaths per 100,000 workers, up from 3.6 in 2021 and the highest since 2008.

From a historical lens, OSHA has had a dramatic effect on worker safety. In the late 1960s, as Congress began debating the law that would become the Occupational Safety and Health Act of 1970, an estimated 38 workers a day were dying on the job. In 2022, the average was 15 worker fatalities per day.

So far, Florida and Texas have banned municipalities from passing ordinances that require breaks for outdoor workers, with similar laws pending in other states. On the positive side, new laws in California, Colorado, Minnesota, Oregon and Washington provide greater protections for construction workers and others toiling in hot weather.

OSHA funding was up slightly in fiscal year 2022 (Oct. 1, 2021-Sept. 30, 2022), a trend that has continued in the 2023 and 2024 fiscal years. But the agency is only beginning to climb out of a deep hole.

For example, in 1975 – four years after the OSH Act, signed into law by President Richard Nixon, took effect on the nation's second observance of Workers Memorial Day - OSHA had 2,435 inspectors and other staff responsible for the safety and health of 67.8 million workers at nearly 4 million workplaces.

This year, there are 1,962 federal OSHA staff responsible for 150 million workers at more than 11.5 million workplaces. With a fiscal 2024 budget of \$632 million, according to AFL-CIO calculations, the agency has just \$3.93 for every worker it is charged with protecting.

"Even that tiny sum is more than some opponents in Congress wanted OSHA to have," Cooper said. "No one can argue with a straight face that OSHA doesn't need more resources. Too many workers are still being killed, injured and sickened on the job with lifelong consequences for them and their families.

"It is gut-wrenching to think how many of those tragedies could have been avoided if OSHA had the money, inspectors and enforcement tools it needs," he said. "We want to open the public's eyes to that as mark another Workers Memorial Day and remember the brothers and sisters we've lost."

### Maintaining eggs-cellent fisheries 🚽

eggs equals zero fish for future stocking programs. So, the spring walleye and steelhead egg collections by the Michigan Department of Natural Resources are critical components of the strategy for maintaining world-class fishing opportunities

in the Great Lakes State. Walleye fishing (and the fish fries that follow) are a quintessential part of Midwest culture. Whereas this species does reproduce naturally in some large rivers and northern Michigan lakes, many of the popular walleye fisheries in the state are dependent on stocking. The DNR uses two donor populations to supply the eggs for statewide stocking programs.

Lower Peninsula – Muskegon River. The DNR's 2024 walleye egg collection efforts began on the Muskegon River on March 26. Personnel from the Southern Lake Michigan and Central Lake Michigan management units used an electrofishing boat to capture adult walleye downstream of Croton Dam in Newaygo County.

Walleye were transported to holding pens at the Pine Street boating access site, where a fishprocessing assembly line was created. One Wolf Lake State Fish Hatchery employee stripped eggs from a female walleye into a bowl. Another person collected milt from a male walleye, then added the milt to the bowl to fertilize the eggs. Both male and female walleye were released back into the river after these steps.

A third hatchery worker added the eggs to a bucket where they were mixed with a type of fine clay that coated the eggs and prevented them from clumping together. Next, the eggs were poured into a mesh bag in the river to water-harden for about an hour. This step is crucial as fresh

eggs are very fragile.

Finally, the eggs were loaded into buckets and transported to the Wolf Lake State Fish Hatchery in Van Buren County. The same process was repeated on March 28, April 2, and April 4, except some of the eggs collected on April 2 went to the Platte River State Fish Hatchery in Benzie County. In total, over 31 million walleye eggs were collected from 195 male-female pairs on the Muskegon River this spring.

**Upper Peninsula – Little Bay de Noc.** Meanwhile, in Delta County, although a mild winter in the Upper Peninsula with low snowfall and mild temperatures led to earlier than normal ice-off conditions on Little Bay de Noc, egg take efforts were completed on April 10, 12 and 14, which were close to the long-term average dates over the past 30 years.

deemed "extra" fish. For over 30 years, several hundred adult walleye have been jaw-tagged – with small circular bands that attach around part of the jaw – and then released.

Each tag has a unique number stamped on it. When anglers catch and report a tagged fish, this gives researchers information on the movements and habits of individual walleye in the northern Green Bay area of Lake Michigan.

The walleye collected on the Muskegon River and Bay de Noc this spring will remain inside the hatcheries until they reach the fry stage. At that point, they will be moved into rearing ponds located throughout the state to grow to a size suitable for stocking. Many of these fish will be stocked in June when they are around 1-2 inches in length, whereas walleye from a few ponds will be held until October and stocked at around 6 inches long.

**Steelhead efforts.** Steelhead capture the attention of a diverse swath of anglers. Whether you're trolling the vast waters of the Great Lakes, quietly waiting for that bite on a deserted beach or standing waist deep in an ice-cold stream, steelhead fishing offers year-round opportunities.

To create, enhance, and supplement this amazing Michigan fishery, steelhead eggs are collected every spring at the Little Manistee River Weir in Stronach in Manistee County.

This process typically begins in March when grates are lowered on the weir structure to stop the upstream migration of lake-run rainbow trout, more commonly called steelhead. Once large numbers of steelhead have gathered below the weir, pumps are activated that flood the facility ponds and raceways, offering steelhead a passageway.

Steelhead are then guided into ponds where they will ripen for egg collection. The spawning period for steelhead in streams begins in late March and continues through April. This is the same time frame that eggs are collected at the weir.

A day of egg collections begins by preparing the workspace for all the various steps that are necessary for success.

Buckets for the individual

collection and buckets for transportation to hatcheries must be cleaned and labeled. Cups for collecting milt from male steelhead must be numbered to spawn one female with one male. Egg treatment and disinfection solutions must be mixed to exact recipes to ensure eggs have the best chance at fertilization and survival.

Once staffers have everything prepared at their station, it's time to bring in the fish.

Steelhead are moved from the ponds and through the raceway with a machine called a crowder, which has a basket that herds the fish and can lift them into a large tank inside the facility.

Fish are then moved from the tank onto a table to determine ripeness and to sort males and females. Ripe fish are then put into a separate tank where they are sedated to assist with handling.

Eggs are removed from ripe females using a small needle that blows compressed air into the body cavity, pushing the mature eggs out of the fish and into a small bucket. Milt from a mature male is captured in a paper cup and added to the bucket of eggs.

Next, a solution mixed for fertilization is added to the bucket, and in a matter of seconds the eggs will be fertilized. Spawned fish are moved to a recovery pond before being released upstream of the weir. On an average day, this process will happen over 200 times.

From this point, the eggs are disinfected, water-hardened and placed on an egg battery that cleans the mixed egg buckets with oxygenated river water. These are now healthy steelhead eggs ready for transport to waiting hatcheries where staff will rear the young fish over the next year.

The steelhead egg quota this year is just shy of 6 million eggs, which will support the stocking programs of Michigan, Ohio and Indiana.

The efforts of DNR fisheries staffers to collect eggs each spring help provide sport anglers with hours and hours of fantastic walleye and steelhead fishing fun, along with countless meals eaten by resident families, individuals and visitors to Michigan from near and far – one example of the numerous things that help make the Great Lakes State great!
