AFL-CIO: Dems need to drop union-busters

WASHINGTON (PAI)—AFL-CIO President Liz Shuler says she expects the Democratic Party, whose campaigns and candidates heavily depend on union volunteers and contributions, to ban anti-union consultants from serving those candidates and campaigns.

In a brief statement, Shuler told *Politico* the Democratic National Committee decided “to amend their contract and RFP (request for proposals) processes to exclude firms actively working with clients who seek to prevent or limit working people’s basic rights to act collectively.”

The DNC responded it is “reviewing” that issue, *Politico* reported. Some of those consultants, including one who served former Democratic President Bill Clinton, are union-hostile. That tripped up one consultant, Washington-based GSG, and raised the issue.

News reports showed Amazon hired GSG to advise and participate in its vicious campaign to stop the grass-roots Amazon Labor Union from winning a National Labor Relations Board recognition election at the monster retailer and warehouse’s large JFK8 facility on Staten Island. ALU won a substantial majority for unionizing, in a heavy turnout.

Who’s working in construction?

The Center for Disease Control’s National Health Interview Survey provides some interesting demographic and socioeconomic details on construction workers.

As of 2020, here’s what the data shows, according to Center to Protect Workers’ Rights researchers who released their findings in January:

- Nearly one-third (31 percent) of construction workers are in the age 18-34 demographic.
- 11.4 percent of construction workers are female
- 31.4 percent are Hispanic
- About three-quarters (74 percent) of construction workers were born in the U.S.
- 43 percent of construction workers are married
- The highest concentration of construction workers is found in the South (40 percent); followed by the West (26.1 percent); Midwest (18.1 percent) and Northeast (15.8 percent).
- Nearly three-quarters of construction workers (73.3 percent) have no college education.

Death On The Job by the numbers

Following are a few other numbers gleaned from this year’s *Death On The Job* report from the AFL-CIO, found elsewhere on this page:

- Older workers were at high risk, with more than one-third of workplace fatalities occurring among workers ages 55 and older in 2020.
- Musculoskeletal disorders accounted for one in five of all workers who reported workplace injuries or illnesses, more than any other type of injury or illness.
- The average employer penalty for a serious violation was only \$4,460 for federal cases and \$2,421 for state plans. Only 115 worker death cases have been criminally prosecuted under the OSH Act since 1970.

MSU Federal Credit Union branches out with campus tower

EAST LANSING—Michigan State University and its 50,000 students, faculty and staff dominate the comings and goings of the city, its streets and buildings.

Of course it never hurts to diversify, and the MSU Federal Credit Union is helping the city do just that in the neighborhood just north of Grand River at Abbot Street. The longtime banking fixture is building a new seven-story, 87,822-square-foot office building that will include a credit union

branch, office space for the company, two floors of leased space and a community room for non-profit organizations.

“We have wanted to have a larger presence in the core of East Lansing but it just wasn’t possible 15 years ago. It is possible today,” said the credit union’s Board of Directors and President/CEO April Clobes when ground was broken at the site in July.

“This building will bring office workers, student interns, and a new branch to serve members with knowledgeable employees and integrated technology. It will also have a community space for

events and for people to gather together to celebrate, much like we are doing today. There will also be additional space available, perhaps retail space for start-ups or for art exhibitions. The Credit Union is committed to the community and to the community’s success, and to bringing vitality to this space.”

Granger Construction is managing the project, which is currently employing an abundance of Iron Workers Local 25 members employed by Assemblers Precast & Steel Services, (Continued on Page 2)

Growth likely ahead for fidgety industry

The zig-zag line of building activity in the nation has continued into the first quarter of 2022, but the long-term trend still looks good.

That’s the latest from the Dodge Construction Network, which reported on April 19 that despite a major dip in nonresidential construction spending in March (dropping 29 percent from February), U.S. construction

starts were 9 percent higher in the first three months of 2022 compared to the same period in 2021. The numbers indicating the large drop in the nonresidential sector in March had been skewed upward a bit by the start of three major projects in February.

“The volatility caused by the ebb and flow of large projects masks an underlying trend of strengthening in construction

starts,” stated Richard Branch, chief economist for Dodge Construction Network. “Nonresidential construction has benefited from the growing confidence that the worst of the pandemic is in the rear-view window. The pipeline of projects waiting to start continues to fill, suggesting this trend will continue. However, higher prices and a shortage of skilled labor will slow the

progress of those projects through the design and bidding stages, resulting in moderate growth in starts activity.”

For the 12 months ending March 2022, nonresidential building starts were 25 percent higher than in the 12 months ending March 2021, while residential starts improved 15 percent, and nonbuilding starts (usually infrastructure) were down 1 percent.

Workers Memorial Day emphasizes hardships, safety at worksites

Shoving merchandise around Amazon’s giant warehouse in Bessemer, Ala., isn’t easy, Isaiah Thomas says. It also isn’t safe.

And, according to the AFL-CIO’s 31st annual *Death On The Job: A Toll Of Neglect* job safety and health report, that’s unusual, either

That’s because federal fines against bosses for job safety and health violations are still too low “to be a deterrent” to lawbreakers on safety, the report adds.

“I’m 20 years old, and I already have back problems,” says Thomas, a lead advocate in the Retail, Wholesale and Department Store Union’s ongoing unionization drive at the monster facility. And since Bessemer opened two years ago, six of his co-workers have died.

“The company I work for, Amazon, puts profits above safety of its workers,” Thomas told an April 26 Zoom press conference the AFL-CIO hosted to release the report, honoring Workers Memorial Day, April 28. “Every day, we’re standing 12 hours” on the job, with only one 30-minute break, Thomas explained. “Working in a warehouse in this heat is absolutely insane. People become delirious.”

Incomplete data about how many workers the coronavirus on the job infects, and how many die, by industry, is one big job safety problem workers face, according to the report, AFL-CIO President Liz Shuler and the federation’s safety and health director, Rebecca Reindel.

“Every single day, 340 people die from work-related injuries and illnesses,” Shuler said. That includes deaths of former workers from ailments such as black lung disease.

Using data from all sources, including cases where employers actually reported coronavirus cases to the feds, “other sources” i.e. not specific reasons, such as falls, cost men 169,260 days away from work in 2020, and were the leading cause of such missed days for men. For women, health care was the worst occupation for illnesses, causing them to miss – in three sectors – 341,700 days.

Other summary figures are stark:

• In 2020, the most recent year data is available, 4,764 U.S. work-

ers died daily from hazardous working conditions, or 340 per day. Deaths declined by 569, compared to 2019, but Reindel noted the pandemic skewed the data.

The number of hours worked at jobsites in the U.S. declined by almost 10 percent in 2020, compared to 2019. The data omits workers who worked

Anxieties aside, contractors optimistic about U.S. construction

The nation’s construction subcontractors certainly have their share of concerns these days – but they remain a confident lot.

So says the results of a new survey, conducted in February, of nearly 800 commercial construction subcontractors, most of whom have been in business for more than a decade. The survey, called the 2022 *National Subcontractor Market Report: How Labor Shortages & Market Volatility are Impacting Subcontractors*, “indicates subcontractors remain concerned about volatile material prices and labor shortages but are optimistic about continued growth over the next year, says Billd, the report’s sponsor.

This was the second annual survey on the subject by Billd, a leading provider of material and labor financing solutions for commercial subcontractors,

“Billd’s 2022 *National Subcontractor Market Report* confirms a lot of the known challenges and opportunities subcontractors experience across the industry,” said Chris Doyle, CEO of Billd. “The labor and material challenges for subcontractors is not just a headline, it’s the day-to-day reality for every subcontractor in the country. Despite these challenges, subcontractors remain optimistic about their businesses. This report highlights the entrepreneurial spirit subcontractors continue to exhibit each and every year, despite an industry that’s largely turned its back on them.”

According to the report, released April 26, 88 percent of those surveyed expect continued price turbulence to impact their business this year, a 9 percent

Pandemic leads to spike in construction worker anxiety, depression

More construction workers are feeling anxious or depressed since the start of the COVID-19 pandemic, according to a study released in January. While this increase mirrors general nationwide trends, it’s especially troubling given that the construction industry already has the second-highest suicide rate in the country.

Researchers at CPWR – The Center for Construction Research and Training – analyzed data from the CDC’s National Health Interview Survey, including a subset of construction workers who were interviewed about their mental health in 2019 and again in 2020. In that subset, nearly 43

percent reported feeling more anxious or depressed in 2020 (after the pandemic) than in 2019 (before). Specifically, 37.3 percent felt more anxious and 18.4 percent felt more depressed.

Of those workers who said they experienced more anxiety or depression, just under half (46 percent) were under 55 years old, compared with just 33.7 percent of workers over age 55. Slightly more females (49.8 percent) than males (42.2 percent) reported more anxiety/depression.

Not surprisingly, CPWR also found that “workers whose general health worsened during the pandemic were also more likely to report growing anxious/depressed feelings than those whose health improved or did not

change. Looking at 2020 in isolation, more than one in three (36.3 percent) construction workers reported that they were “not in very good or excellent health.” Over-

all, 24 percent reported “binge” drinking in the past month, and 7.2 percent said they had used prescription opioids in the same time frame.

PLA executive order boosts worker wages, jobsite safety

In February, President Biden signed an executive order that will substantially strengthen the use of project labor agreements on federal construction projects. The order requires PLAs on directly funded large-scale projects with contracts of \$35 million or more.

All contractors and subcontractors on the project will be required to participate in the PLA.

This new executive order goes beyond a similar 2009 executive order issued by the Obama Administration, which permitted federal agencies to use PLAs on a project-by-project basis, but didn’t require them.

President Biden’s executive

order also expands the scope of applicable projects to include reconstruction and modernization projects for buildings, highways and other federal property. This is a significant addition, since many upcoming projects under the \$1.2 trillion bipartisan infrastructure bill will involve revitalizing and modernizing existing

Low wages become a public burden

President Joe Biden's tenure has been marked by a relentless focus on creating good jobs for working Americans. In addition to the record 7.9 million jobs created during his time in office, he recently signed into law the Infrastructure Investment and Jobs Act (IIJA), which will create hundreds of thousands of new jobs and sustain millions more.

The United States urgently needs more high-quality jobs, and the administration has also taken several steps to boost wages such as by raising the contractor minimum wage to \$15; increasing equity and access for workers from all walks of life; and holding accountable corporations that violate workers' rights.

Now, the Biden-Harris administration is updating regulations governing the Davis Bacon and Related Acts (DBA) to ensure that workers on construction projects that receive federal funding are paid fairly. While the draft rules may be overlooked by some, they will improve the lives of 1.2 million workers; ensure local, law-abiding contractors can compete on an even playing field; and help guarantee that IIJA investments and other government spending provide a good value to the public.

DBA protections — which require recipients of government contracts, loans, grants and other types of government spending to pay their workers local, market wages and benefits — apply to approximately \$217 billion in construction spending per year. In addition, the vast majority of the infrastructure law's investments include prevailing wage protections.

Research shows that

strong construction wage protections allow workers to earn middle-class incomes; expand access to health insurance and pension plans; and increase homeownership rates. These standards also help close wage gaps between Black and White construction workers and, when paired with other interventions supported in IIJA such as local hiring requirements, increase recruitment of historically marginalized groups to good jobs in the construction industry.

In other words, prevailing wage laws help create the sorts of jobs that are essential to a healthy American middle class but are currently in short supply. For example, recent analysis from the Economic Policy Institute finds that while net productivity grew by nearly 62 percent over the past four decades, average hourly pay for the typical worker increased by just 17.5 percent.

Yet, existing federal prevailing wage standards are woefully outdated. The typical American worker was still in preschool the last time these regulations were updated. Moreover, Reagan-era changes weakened the law's ability to support working people by divorcing wage determinations from actual market pay. And today, weak enforcement tools result in wage theft that can reduce a misclassified construction worker's total compensation by approximately 29 to 36 percent.

When low-road contractors beat out law-abiding contractors based on low and even illegal wages, the public shoulders the burden. Weak prevailing wage protections increase Americans' reliance on assistance programs like the Supplemental Nutrition Assistance Program (SNAP).

And recent research from the Center for American Progress finds that nearly 30 percent of contractors with the worst records of workplace law violations also have significant performance problems on subsequent government contracts — including submitting fraudulent billing statements; falsifying qualifications for contract employees; accruing major cost overruns; and producing defective and sometimes dangerous equipment.

The DBA draft regulations would uphold fair treatment of working people by ensuring wage determinations are updated more frequently, keep pace with inflation and better reflect the actual wages most widely being paid in local communities. Moreover, the regulations will improve compliance with the law by increasing remedies for workers who are illegally fired or otherwise retaliated against for reporting violations and ensuring that the worst violators are barred from doing business with the federal government.

Indeed, after Maryland increased contracting wage standards, bids for government contracts increased by nearly 30 percent. By modernizing DBA standards now, the federal government will encourage more law-abiding companies that respect their workers and the public to compete for contracts and help guarantee that new IIJA investments create the good jobs that the American economy so desperately needs.

Inc., performing structural work.

Precast installation started about a month ago with the west tower, then the north precast wall followed — erected in unison with the center section of structural steel. Steel erection is expected to be completed in June. Mechanical and plumbing work has also commenced.

new and sustained job growth in downtown East Lansing," said Kathy Buck, senior project manager at Neumann/Smith, the architectural firm for the building. "It will introduce office space, which is currently lacking in the downtown core, and establish a workforce that will help to support other local businesses. It will build upon other developments that have been constructed over the last several years to help strengthen and create a more diverse downtown for the citizens of East Lansing to enjoy."

In recent years the area has seen construction of a new small format Target store, the 12-story, 464-unit Landmark apartment building, and the 13-story, 196-unit Abbot Apartments.

The space is also something residents have wanted for a long

time but that developers haven't offered until now, Mayor Aaron Stephens said.

"The new credit union building "is going to help our businesses, this is going to help our downtown succeed, and it's going to lead to a lot of diversity of options in East Lansing," Stephens told Fox 47. "Typically we think of East Lansing downtown as a bunch of college bars, and that's just not how it is any more. And this just proves that."

BUILDING MICHIGAN: Dolomite HISTORY IN THE MAKING

DURING THE CONSTRUCTION of the Mackinac Bridge's foundations in 1954, a section of a double-walled tower caisson pokes up above Lake Huron. The outer ring is filled with dolomite, which acts as weight to drive it down. The "overburden" material inside the ring – rock, sand, and mud – is removed by crane and clam bucket and dumped over the side. The weighted cutting edge drives the sharpened edges down into bedrock, like a cookie cutter. When positioned the whole caisson is filled with aggregate and grouted to make it one solid mass of concrete.

Hail dolomite!

When the North American glaciers receded 10,000 years ago, they left behind all manner of rock formations and minerals that made Michigan a uniquely geologically diverse state. Nickel, copper, iron, limestone, gypsum, potash and even salt have all been harvested and monetized, just to name a few.

Then there's the rock with a funny name: dolomite (made of calcium magnesium carbonate) which is basically a cousin of limestone (made of calcium carbonate). The chemical properties of dolomite make it a rock of potentially tremendous versatility.

Perhaps dolomite's most notable use was in the foundations of the Mackinac Bridge, constructed between 1954-57. During construction, lake freighters with 12,000-ton loads carrying the stone made the 80-mile, round-trip circuit to a still-operating quarry on Drummond Island in Lake Huron. Dolomite stone from the conveniently located quarry was the aggregate used in the 931,000 tons of concrete that went into the bridge's foundations.

Michigan has significant limestone/dolomite deposits in the northern Lower Peninsula and eastern Upper Peninsula. According to a state government-sponsored 1950s-era geological survey, Michigan has "practically unlimited supplies of high-purity dolomite," measurable in the billions of tons.

"The most common use for dolomite is in the construction industry," says *Geoscience News and Information*. "It is crushed and sized for use as a road base material, an aggregate in concrete and asphalt, railroad ballast, rip-rap, or fill. It is also calcined in the production of cement and cut into blocks of specific size known as 'dimension stone.'"

"Dolomite's reaction with acid also makes it useful. It is used for acid neutralization in the chemical industry, in stream restoration projects, and as a soil conditioner. Dolomite is used as a source of magnesia, a feed additive for livestock, a sintering agent and flux in metal processing, and as an ingredient in the production of glass, bricks, and ceramics."

In addition to its use underpinning the Mackinac Bridge, the rock is also used at numerous ports and shorelines of the Great Lakes, acting as a material in dock installations or for shore preservation. And the state capitol for dolomite is the aforementioned Drummond Island, a 134-square-mile piece of land in Lake Huron on the eastern tip of

the Upper Peninsula.

"Drummond Island," says the Drummond Island Tourism Association, "is part of what geologists call the Engadine corona, which is a vast formation of dolomite originating on the eastern tip of Great Manitoulin Island and extending westward in a great arc to the vicinity of Manistique in Michigan's Upper Peninsula. Dolomite, the underlying rock of Drummond Island, is calcium carbonate with a high percentage of magnesium carbonate."

Dolomite is more than just your basic rock. Back in the early 1800s, when the British controlled the region, their soldiers believed dolomite was ordinary limestone, and burned the rock to extract the lime that they used to erect Fort Drummond on the island. Later, Americans employed Drummond Island's dolomite to help build the early locks at Sault Ste. Marie.

"In the late twenties, T. L. Durocher, of DeTour opened the present Drummond Island Quarry to obtain rock for the construction and rip-rapping of docks and breakwaters on the Great Lakes," writes Candis Collick for *U.P. North Life*. "Mr. Durocher, a marine contractor, realized that the blocky nature of Engadine dolomite made it ideal for this purpose."

"Within a few years, several hundred thousand tons of it were quarried and transported for the repair and construction of marine installations at Frankfort, Mackinaw City, South Chicago, and other Great Lakes points. By 1949 Drummond Dolomite was a 24-hour per day operation and they shipped out 2,275,000 tons that year."

According to a 1954 state publication called *Mineral Resources of Michigan*, "By 1945, the Drummond Dolomite Corp. had 'grown into one of the world's largest dolomite producers, by providing a high quality raw material for chemical, steel and construction purposes throughout the Great Lakes area. Dolomite has various uses in industry: concrete, glass making, paper making – even in the making of such medicines as Epsom salts – but the steel industry is by far the greatest user.'"

The Mackinac Bridge builders came calling to Drummond Island as plans for the structure were coming together. The five-mile-long bridge project that would connect the state's two peninsulas began in 1954. And they could use the aggregate as a weighty ingredient in building the piers and foundations. After all, Drummond Island was easily accessible via Lake Huron

and their operations could be ramped up to provide the stone needed for the Mighty Mac.

Dolomite from Drummond Island was shipped in self-unloading lake freighters to the bridge site. These vessels carried 12,000 tons per load.

"One of the first steps" in the construction of the Mackinac Bridge, wrote Collick, "was to sink the large, double-walled cylinders that form the bases of the two main tower piers. These cylinders are called caissons. Sunk down into the bedrock on the lake floor – the caissons presented a great challenge for the divers involved in their fabrication."

"The massive cylinders that would anchor the bridge's two main towers were sunk to bedrock, about 210 feet below the surface," of the Mackinac Straits, wrote Pete Sigmund in *The Mighty Mac: A Sublime Engineering Feat*. "In each watertight caisson section, 44 ft. high and 116 ft. in diameter, grout tubes were placed 20 ft. apart from the surface of the water to the bottom. Aggregate (in the form of dolomite) was then placed around the pipes to a height of 40 ft. on each section so that the interior of the caisson was solid, like concrete. The caissons, with tapered leading sections, could cut into the overburden at the bottom."

Bridge foundation contractor Merritt, Chapman and Scott used an innovative concrete method called Prepak concrete, which allowed them to place coarse aggregate into forms, then place grout tubes within that coarse aggregate, and then use the tubes to pump cement and fine aggregate in among the coarse aggregate, creating concrete. This way builders didn't need big mixers and could create the concrete more quickly.

A bronze plaque affixed to the Mackinac Bridge marks the use of dolomite to build temporary Mackinac Bridge Authority office buildings on Drummond Island – and on the bridge itself. "The face of the Authority's buildings and the foundations of the bridge are built of Drummond Dolomite Stone from Drummond Island, Mich.," says the plaque.

Today, 83,000-acre Drummond Island is accessible by ferry, and the 3,000-acre dolomite mine "is the only actual industry on the island, and it still operates today. The mine is the first thing a visitor sees when arriving on the car ferry. The entire island economy revolves around this mine and tourism," writes Mikel Classen in *Island in the East*.

Anxieties aside, contractors optimistic about U.S. construction

jump over 2021. A similar 87 percent say the lack of availability of materials will keenly impact their business in 2022. The survey found labor issues, however, are now the most pressing concern of U.S. subcontractors, with 40 percent reporting availability of skilled construction workers as their "biggest risk" in 2022, compared to 30 percent who stated material price volatility as their top concern.

Subcontractors also reported that despite higher material and labor prices, they surprisingly have not reflected those higher costs in their project bids, putting greater strain on subcontractor profit margins.

The lifeblood of any business – maintaining positive cash flow – is also a critical subject for construction subs. Input prices for construction materials rose 21 percent in the year leading up to March 2021.

"While subcontractors remain satisfied with their financing and credit options," Billd said, "they feel the pressure of paying for large material and labor costs upfront, disrupting their cash flow." The survey revealed that 59 percent of contractors intend to rely on cash to fund business growth in 2022, while nearly half state cash flow remains a significant challenge.

Still, 71 percent of respondents said they planned on growing their business this year (down from 74 percent in 2021), while 50 percent said they planned on pursuing larger projects (down from 62 percent a year ago).

"Subcontractors are resilient and optimistic but need more tools to navigate this increasingly challenging environment," said Doyle. "The payments supply chain in construction is terribly broken, leaving subcontractors to finance a \$1.5 trillion industry with very few cash flow solutions offered to them."

PLA executive order boosts worker wages, jobsite safety

U.S. roads, bridges and water lines.

"With this executive order, the Biden administration is continuing to send the message that using union labor is the right choice for our economy, for getting projects done on time and for worker safety," says Laborers International Union General President Terry O'Sullivan.

The benefits of projects labor agreements. Project labor agreements are collective bargaining agreements between unions and contractors that govern project terms and conditions for all workers – both union and nonunion. Under PLAs, workers are paid strong, prevailing wages throughout the project and a steady source of trained, skilled workers helps ensure projects are completed safely, on time and on budget. PLAs also often include provisions such as local hire requirements to ensure projects benefit the surrounding community. As an example, consider this comparison of two projects in the Washington, DC metro area:

Operating under a PLA, Phase I of the (Dulles Metrorail) project was not plagued by the problems that have burdened other large non-PLA projects in the region. For example, the nearby Springfield Interchange – originally a \$200 million project – wound up costing taxpayers nearly 300 percent more. Five workers died during construction and only legal action against a contractor gave it a chance of finishing on time. By contrast, the PLA on the Dulles Metrorail kept the project on time and on budget – and without a single worksite death or lost time due to accidents because workers were skilled and well-trained.

Why operating under PLAs increases safety on projects. Support for PLAs often focuses on the clear economic and business benefits for owners and communities, but the positive outcomes for worker safety and health shouldn't be ignored either. Using union labor on these projects means workers show up with the skills and safety training to do the job safely. Study after study has found that the union safety advantage is real, with union construction projects generally having a superior safety record compared to non-union projects.

In addition to governing wages and benefits, PLAs can also spell out the health and safety requirements specific to the project. This leads to better working conditions by requiring both contractors and workers to comply with project safety rules. Provisions could mandate all contractors on site have a written, site-specific safety and health program or meet certain benchmarks for recordable injury and illness rates or experience modification rate (EMR).

Large union construction firms can meet these requirements because they tend to have strong safety management programs already in place. Because PLAs cover all contractors on a project, including smaller subcontractors or non-union contractors, these firms have to meet the same safety standards as well. This levels the playing field by ensuring the same commitment to safety across the entire site. This is important on large projects, where it's common for multiple crafts and multiple contractors to be working together.

PLAs can bring structure and stability to large construction projects. In addition to strengthening safety and health, PLAs help ensure compliance with equal employment opportunity and labor standards. These agreements open new career opportunities for women, minority groups, veterans and other under-represented populations.

A new standard for federal construction contracting. In addition to mandating PLAs for projects over \$35 million, President Biden's executive order also gives federal agencies the leeway to use PLAs on projects below this threshold. This option should create additional opportunities for LIUNA district councils, local unions and signatory contractors to advocate for bringing the benefits of PLAs to smaller federal construction projects as well.

With the fatality rate for construction laborers the highest it's been in over a decade and the clear safety and health benefits of PLAs, we should be taking steps to bring PLAs to as many projects as possible.

to report increased anxious/depressed feelings in 2020 than those without a college education (50.5 percent versus 39.0 percent).

"This was also observed more frequently in white-collar (47.0 percent versus 41.4 percent blue-collar) and part-time (49.2 percent versus 43.1 percent full-time) workers," CPWR researchers said. Overall, the data showed that workers "who were young, female, working part-time, less healthy, or living below the poverty level were hit harder by anxiety/depression (defined by frequency or level of feelings/use of medication). Hispanic workers were more likely to report increased feelings of anxiety/depression during the pandemic compared to non-Hispanic workers. Socioeconomic stressors and job insecurity arising from unemployment and nonstandard work arrangements during the pandemic may underlay some of these differences."



Projects that may hire are obviously SK Siltron. The steel is still going up on this project and has seen some delays due to material. The good news is another \$300 million is headed towards this project late this fall with the next phase to begin in January of '23. Gage Grow, Liberty Bridge, Cheboygan Wastewater and both Goyette Mechanical Projects (Hale Schools and the Ground Water filtration system at the old Wurtsmith) may also hire in the near future.

Rest assured both organizers and myself are working very diligently to secure whatever work is being bid in our jurisdiction for our membership. Detroit and Lansing are the place to be in the state right now if you are looking to travel. Ann Arbor will be good shortly. Please contact the hall if you would like to sign any books.

Organizers Report. 692's Organizing team continues to reach out to unrepresented workers in our jurisdiction about the benefits of joining the IBEW. The second quarter of 2022 will see demand for local manpower increase considerably. The ability to provide adequate manpower to larger-scale projects will only strengthen our contractors' chances of securing this work. The IBEW work outlook looks strong statewide as well, with larger projects coming to Detroit, Lansing, West Michigan and elsewhere. If you'd like to register on any other IBEW out-of-work lists, please reach out to the hall.

Bay City commissioners recently adopted a Responsible Contracting ordinance that will ensure projects funded by taxpayers are completed by reputable firms. Responsible Contracting language prioritizes criteria such as workplace safety, the utilization of a local workforce, and adhering to licensing and permitting requirements when awarding contracts on larger-scale construction projects and city contracts. No longer will cost be the only criteria when considering contractors looking to secure work in the city. As with any new process, there will undoubtedly be some growing pains. 692 agents will continue to assist our signatory contractors in navigating the new bidding process included in this important ordinance.

IBEW organizers in the State of Michigan are currently involved in a campaign against United Electrical Contractors, a large merit shop based in Lansing. A Federal EEOC lawsuit has been filed by six former United employees due to the unfair treatment, discriminatory and blatantly racist behavior they experienced at the hands of management. The IBEW stands in solidarity with the United Six+ (the "4+" has been added as more than the initial six former employees have joined the lawsuit). We also stand up for all other working people who demand accountability from employers who fail to respect their human rights. Local 692 continues to join other locals in protest to demand contractor accountability and promote dignity for all working people within our industry. Please follow the Justice for the United Six campaign on Facebook, and do everything in your power to keep our jobsites safe, inclusive, and free from discrimination.







MISINFORMATION ISN'T new. Given human nature, it wouldn't be surprising if there were radical, pre-historic cave-men who shouted conspiracy theories about neighboring tribes to whoever would listen. In today's digital age, however, misinformation can literally circle the globe at the speed of light, reaching millions of people. And when that misinformation is about medicine, the results can be catastrophic.

Recently, the World Health Organization coined a new word, "infodemic," which it defines as "an overabundance of information, both online and offline" that "includes deliberate attempts to disseminate wrong information to undermine the public health response and advance alternative agendas of groups or individuals."

False information about vaccines makes up a large segment of medical misinformation, though even before vaccines were introduced, misinformation regarding masks and the severity of Covid-19 abounded.

Preventable Deaths

For example, according to research by the Kaiser Foundation, covering June-November of 2021, approximately 163,000 American Covid-19 deaths during those six months would've been prevented if the victims had been vaccinated. We'll never know how many of those individuals refused vaccines due to exposure to misinformation, but the sheer volume of misinformation on this topic makes it probable that the percentage is high.

In a recent survey published by GoodRx, among a representative sample of more than 1100

The Deadly Consequences of Medical Misinformation

While "Truth Decay" has diminished trust in science and educated experts, it has also left many wondering where to turn for reliable information.

Americans, 73 percent reported being exposed to medical misinformation, and another 16 percent were unsure. Not surprisingly, the leading source of misinformation was social media (82%), followed by friends (66%), TV news (64%) and general internet searches (60%).

Look out for "Truth Decay"

On the plus side, the digital age ensures that useful information is out there. But to take full advantage of that accurate information, you must be able to sniff out opinions presented as facts. That leads us to another recently coined phrase, what the RAND Corporation calls "Truth Decay," which it defines as "the diminishing role of facts in American public life."

While "Truth Decay" has diminished trust in science and educated experts, it has also left many wondering where to turn for reliable information.

Writing in the RAND Blog, Jennifer Kavanaugh, lead author of RAND's semiannual Truth Decay report, suggests seeking out experts for information on any complicated subject. "For example," she writes, "if you're looking for information about how Covid-19 spreads, seek out physicians or scientists who specialize in infectious diseases."

Additionally, be careful about taking advice from health professionals who advance political points of view that are out of

the mainstream. Legitimate scientific inquiry includes rigorous questioning and critical thinking, which shouldn't be confused with popular rhetoric that creates fear and distrust.

What And Where To Look?

If you're looking for help online, the National Institutes of Health (a nonprofit, non-political, government organization), lists several criteria for finding sound medical advice, such as:

- verify a website's sponsor/owner
- is the author stating opinions or a limited set of facts?
- what is the site's purpose?
- is the article recent?

But when it comes to your own health questions and concerns, remember that the internet is no substitute for a conversation with a trusted health professional.

Mapping Michigan's forests

In 2011, ABC's "Good Morning America" named Sleeping Bear Dunes National Lakeshore in Michigan's northwestern Lower Peninsula the "Most Beautiful Place in America."

But a hundred years earlier, at the turn of the 20th Century, large swaths of northern Michigan looked bleak.

In a time before restorative forestry practices existed, lumber companies cut through tracts of virgin timber stands, leaving slash and stumps. Once the trees were gone, the companies moved on to another stand. In their absence, property taxes went unpaid and land values dropped.

However, in 1922, a team of state government and university officials launched a survey team to create maps that would change the trajectory of northern Michigan's economy and launch the transformation of stump land into the "Water-Winter Wonderland" we know today.

The lumber boom in Michigan peaked in the 1870s and 1880s, but large-scale operations continued into the next century. Today, there are more than 800 logging and trucking firms, 300 wood product manufacturers and mills, and more than 3,000 secondary manufacturers who use wood resources to produce their products.

Lumber is still a viable, big business in Michigan because of improved forestry practices, but in the 1910s, Michigan stood at the precipice of 40 years of nonrestorative logging and lumbering practices.

Regrowing trees on cutover land or timber cultivation had yet to become a mainstream practice, and many Michigan counties teetered on the brink of insolvency from the unpaid property taxes of absentee owners.

Lumber companies and their workers provided the tax base for many communities, funding schools, infrastructure and local government operations. When the companies' interests moved

elsewhere, local governments were left holding the bill.

To make matters worse, lumber companies hired land speculation firms to sell the depleted acreage to get the worthless land off their books. They targeted unsuspecting people who wanted to be their own boss by running a farm in northern Michigan.

While vast tracts were available, the sandy soil produced pine trees, not traditional crops. Even if the soil was good enough to grow food or hay, the markets for goods were either too dispersed or too far away. Good roads to get products to main rail lines didn't exist. The farmers who didn't fail outright eked out a subsistence and couldn't re-

place the lost tax base from the lumber companies.

The cutover land also presented an extreme fire risk. The stumps and brush left by large operations created a tinder box easily ignited by sparks from a locomotive or a lightning strike.

In 1913, the state geologist started to address the issue by convincing the Legislature to appropriate funds for a forest and soil survey, but World War I interrupted the funding. In 1917, the Michigan Legislature passed the Wiley Act to curtail the predatory land sales by speculation companies.

In 1921-1922, with the war over and the state geologist now in the new Michigan Department of Conservation (today's Michigan Department of Natural Resources), he reprised the idea of the statewide survey.

At a forestry conference in 1922, the fast-rising conservationist P.S. Lovejoy championed the survey saying, "Nearly a third of all the land in Michigan has been repeatedly cut and burned over and is now producing little or nothing in taxes or anything else."

Lovejoy shared that financially stable counties had almost three times the education funding per student. Public education in Michigan is funded by property taxes. He continued to press his point.

"These conditions have been denied or winked at rather than offend local pride and because of a vague hope or theory that somehow profitable uses for the idle land would be found," Lovejoy said.

His solution was the economic survey. Lovejoy argued that the state needed to encourage the cultivation and growth of timber as a sustainable resource and a source of tax revenue and that a new survey could help reassess the value of the cutover land, balancing the local tax base and ultimately providing education funding.

Lovejoy helped launch the Land Economic Survey in 1922 as a partnership between the Michigan departments of Agriculture and Conservation, Michigan Agricultural College (now Michigan State University) and the University of Michigan.

The initial survey included Charlevoix County and then expanded, under Lovejoy's direction, to neighboring counties. In 1923, the United States Senate Committee on Conservation met in Michigan and encouraged the state to continue funding the survey as a model for the rest of the nation.

The survey crews worked hard. A typical crew surveyed three to six miles a day. There were two crews, each with a chief assistant who oversaw two field captains. The field captain supervised four foresters and four agronomists. These experts were skilled in the growing of trees or soils and the cultivation of crops.

The crews also had a couple cooks on staff to keep the workers fed in the field.

Unlike with the original surveys of the state that focused on the boundaries of counties and townships, the Land Economic Survey crews noted soil and timber types; bodies of water including streams, rivers and lakes and cultural features, including towns, schools, churches, cemeteries, resorts, mines and lumber camps.

From the initial survey, the team created a base map that other professional engineers and biologists used to create additional layer maps, including soil surveys, cultural features, farms and forests, and maps for hunting and fishing. The team also set up agricultural experiments in certain counties to provide real-time data on crop viability.

The survey work continued into the 1930s, until the Great Depression hampered its progress. The soil surveys continued until 1960, but the story doesn't end there.

The economic legacy of the survey allowed state and local officials to regain some control of a situation in free fall. While it didn't solve every economic problem, the survey provided a literal map for the region's economic future.

Now, 100 years later, the maps serve as a valuable historical resource to view the Michigan cultural and natural landscape. Researchers can compare changing forest types and agriculture, verify ghost town and lumber camp locations, track down cemeteries of family members or locate one-room schoolhouses.

The surviving maps and the records of the Michigan Department of Conservation are available for research at the Archives of Michigan in Lansing.

later, still kill former workers who toiled on "The Pile" in Manhattan after the 9/11 attacks.

"That's tens of thousands of families losing a parent, a child, a sibling, every single year," said Shuler. "Latino and Black workers specifically remain at greater risk of dying on the job than all workers. That is, frankly, unacceptable."

•There were 3.4 on-the-job deaths per 100,000 workers in 2020, down from 3.5/100,000 in 2019. The death rate was 5.2 deaths per 100,000 workers in 1992, dropping to 3.5/100,000 in 2009. It's stalled at between 3.3 and 3.6 deaths ever since.

•2020 death rates for Latino workers (4.5/100,000) and Black workers (3.5/100,000) were higher than the national rate. The death rate for Latino/a workers has risen 15 percent in the last decade, after declining from a peak of 6/100,000 in 2001.

•Job injuries and illnesses cost women workers more days away from jobs (585,540) than they cost men (577,990). More than half the women's losses were in health care.

•Employers reported almost 3.2 million work injuries and illnesses in 2020, and the report repeated that's an undercount. Outside studies, including those of state workers' comp claims, show the actual rate is much higher.

•The federal Occupational Safety and Health Administration lacks enough resources and people to inspect the whole country. It would need 236 years to inspect every current workplace. And about half the states perform their own inspections.

But the biggest resistance comes, still, from business and its political allies, said Reindel. "They try to block and stall worker protections," she noted.

There's one other big difference, Shuler noted: The injury and illness rates decline drastically when union contracts protect workers. "Everyone should have the right to speak out without fear and without retaliation," she declared.
