The Michigan Unemployment Agency estimated that between 2013 and 2015, about 40,000 seekers of jobless benefits were wrongly accused of fraud in making their application with the state Unemployment Agency.

People lost savings, homes, vehicles, and nights of sleep as a result of the scandal, which was the result of a faulty computer system that issued fraud citations with scant human oversight.

Now comes a reminder from the state Unemployment Agency, which says it has made system reforms: an Aug. 19 paperwork submittal deadline has been set for wrongfully accused claimants who could potentially qualify to be part of a class-action lawsuit against the state agency.

The Michigan Court of Claims set the deadline as part of a \$20.9 million settlement of a lawsuit reached in January. Its part of the Bauserman vs. UIA lawsuit, and the settlement requires claimants to return a properly signed release to Analytics Consulting, the settle-

# **Trades work to restore** unique, historic conservatory

DETROIT – Ideal Conbuilding trades union workers have been giving the nation's oldest, continually operating conservatory a whole lotta love.

Opened in August 1904, the Anna Scripps Whitcomb Conservatory on Belle Isle in recent years has been undergoing renovations to its glass dome, the removal and replacement of its deteriorated structural steel truss columns, reglazing of existing glass, and masonry repairs. It's a one-ofa-kind structure in Michigan.

"We're dealing with a lot of deferred maintenance here," said Ideal Senior Project Manager Jim Muer. "But it's an awesome, trophy project, one that you tell your grandkids that you were a part of. We don't often get to be part of a project that's this unique and historic, and it's really great to be associated with it With "conservatory" unword of the day: Webster's

# Supremes giveth, and taketh away... **OSHA** keeps regulatory powers, but future role is clouded by Supreme Court

WASHINGTON (PAI)-Without comment, except for a short dissent by the most rightwing justice, Clarence Thomas, the U.S. Supreme Court denied a corporate challenge to the Occupational Safety and Health Administration's broad powers to inspect worksites, levy fines and write rules as a result. Instead of saying "yes," or "no," the justices declined to hear the case.

The July 2 result in the underthe-radar Allstates Refractory lawsuit against OSHA was a win for workers. But it also must be placed in the context of the court's decision four days before to throw out - on a party-line 6-3 voteso-called Chevron deference.

That decision, putting all federal regulations in the hands of judges or Congress, is extremely important for workers, and not in a good way. It's a win for the corporate class, which can "judgeshop" to stop workers' rights and protections, and gum up rules in congressional dysfunction.

"Workers are breathing a huge sigh of relief" that the justices did not throttle OSHA too, and "that they are not endangered by the justices putting profits before people" in the Allstates case, Marcy Goldstein-Gelb, co-executive director of the laborbacked National Council for Occupational Safety and Health, said in a telephone interview. "It's life-saving for workers and also brings consistency for industry as well."

But Goldstein-Gelb warned corporations would not stop trying to trash OSHA: "There might be another opportunity for companies to sue the heck porations – will take advantage

In the OSHA case, a small Ohio general construction contractor, Allstates Refractory LLC, which provides furnace services to glass, metal and petrochemical plants, sued Acting Labor Secretary Julie Su, saying OSHA's general power to write permanent rules was so broad it violated the U.S. Constitution, which puts (Continued on Page 3)

Court de-claws agencies, gives judges new clout to rule on worker cases

WASHINGTON, D.C. -Since 1984, federal judges have used the Supreme Court's landmark Chevron case as a guide to determine the use of expertise of personnel in government agencies in interpreting ambiguous language in laws.

That was a ruling hailed at the time by the Reagan Administration, but the current conservatives on the U.S. Supreme Court tossed out that precedent on June 28, putting new powers into the hands of judges rather than government regulatory agencies. Further, the ruling makes it increasingly likely that aggrieved legal parties - very likely, cor-

# Union busting, anyone? GOP has a few ideas... Conservatives' 'Project 2025' offers | De-funding NLRB would be an easy way to ease pesky federal oversight a stew of anti-worker schemes

MILWAUKEE (PAI) - A determined AFL-CIO President Liz Shuler warned workers and voters of the massive threat of the conservative Heritage Foundation-commissioned "Project 2025" at a Democratic-called "counter" press conference during

the Republican National Convention in Milwaukee.

Democratic National Committee Chair Jaime Harrison called the July 17 session to better acquaint reporters covering the convention with the negative impact, on workers, voters, rights and jobs of Project 2025, an expansive, detailed 922-page tome, issue by issue and agency by agency, of how President Trump, if re-elected, would re-order government and centralize all power in the White House.

Both parties used to believe "when workers did better, the country did better," Shuler began. Occasionally, that still happens, she admitted. But Trump, ultra-rightists,

WASHINGTON, D.C. - (PAI) Cuts in Labor Department and Education Department funds, and controversial Republican "social

issue" demands dominated the discussion, and angered unions and Democrats, as House members crafted the Congressional money bill for the two departments, plus the Health and Human Services Department, for the fiscal year starting Oct. 1.

The measure passed on a partisan 31-25 vote in the House Appropriations Committee on July 10 and is headed for the House floor, where the ruling Republicans hold a narrow edge. It's also virtually dead on arrival in the Democratic-run Senate, setting up more showdowns over spending later this year.

One big cut – by a third – would be at the National Labor Relations Board. The Republicans on the money panel want to drastically roll back its funding. In the current fiscal year, the NLRB,

controls and practices construction employers can implement to ensure workers are protected. This proposed rule is timely and will mean improved working conditions during this hot summer while employers implement needed controls that will immediately save lives."

All manner of workers have an interest in lowering workplace heat threats. The Chicago Teachers Union made school system protection of students, teachers and staff from high heat hazards especially in non-air conditioned school buildings - a top goal in its upcoming talks with school system management.

Heat has also been an issue in the mass campaign to unionize Amazon, the retail and shipping monster which employs 800,000-1.1 million U.S. workers. Many, if not most, Amazon warehouses, each the size of several football fields, are not air conditioned. At least one Amazon worker collapsed and died from indoor heat stroke.

Heat is a top cause of collapses and death among farmworkers. Letter Carriers have complained for decades about trucks lacking air conditioning.

Biden issued the rule after years of lobbying on the issue by unions and health experts, along with rising numbers of deaths and, now, rapidly rising temperatures due to global warming. He cited the heat in various cities in announcing the rule on July 3.

# Project 2025: scorch unions

Corporate backers of the Trump campaign have tipped their hand. In Project 2025: Presidential Transition Project, the Heritage Foundation unveiled its 900-page wish list for a new Trump presidency and a compliant Supreme Court.

Trump's victory last time was a surprise, and many corporate types view his chaotic term as a missed opportunity. This time Heritage, which is a mouthpiece for big employers, has compiled a long list of people they want Trump to hire and appoint, and a scorched-earth plan for his first 180 days.

Day One they want to fire the best National Labor Relations Board general counsel we've had in my lifetime, Jennifer Abruzzo. Then Project 2025 foresees reclassifying thousands of civil service employees by executive order so they can be fired and replaced with the corporations' loyal troops.

From there, the plan is to bulldoze the protections U.S. workers have built up over 100 years of determination, sacrifice, and unity. It's ugly: abolish overtime pay laws, outlaw public sector unions entirely, get rid of health and safety protections, eliminate the federal minimum wage by letting states set their own, make it harder to receive unemployment, put children back to work like in the 1920s. Hitting building trades workers, they would get rid of requirements for prevailing wage pay and project labor agreements in federal projects.

There's more. They want to get rid of the Department of Education. Ban teaching women's history and African American history in schools - lest we get ideas about how to change things! Ban abortion nationwide.

I'm from Florida, where parts of this playbook are being tested out. My old union, AFSCME Local 3340, represented janitorial, secretarial, and technical workers at the University of Florida in Gainesville for 50 years.

Last fall the contract was shredded and the union was decertified due to a law put in by the Republican legislature requiring 60 percent paid-up membership. (Florida is already a right-to-work state, so members can get the benefits of a union without joining.)

A friend who works for the city water treatment plant lost his union protection (Communications Workers) the same way. He said younger workers on his jobsite don't understand what it's like to work without a union, so they refused to join, leaving the union to be decertified. Project 2025 wants to take this nightmare nationwide.

We're already living with the consequences of Trump's three Supreme Court appointments. The court just got rid of the "Chevron deference" doctrine, so now, when corporations sue over regulations they don't like, judges don't have to defer to the NLRB's or OSHA's interpretation of what the law means - they can substitute their own anti-worker views.

How do we respond? First, we can let our co-workers know that this anti-worker agenda is the real playbook for a future Trump administration, no matter what Trump himself may say about being on the side of ordinary Americans. While Trump has distanced himself from the 2025 plan, many of his former staffers are part of it and they're ready to step into key roles. They know that in the face of congressional gridlock, "personnel is policy."

Second, let's demand a positive program to rebuild our country, and pressure any candidates who are mealy-mouthed about it to get serious: a \$25-an-hour minimum wage, real enforceable rights to unionize, health care for all with no insurance company interference, tax the rich for fully funded schools and transit, unemployment insurance that doesn't run out, stronger Social Security benefits, and a continuation of the Biden Administration's serious investment in jobs for a new green economy to stop climate change. # **Trades restore historic conservatory**

(Continued from Page 1) phases, with the initial focus on restoring the integrity of the 100,600-square-foot dome. Work has included removing and replacing the dome's deteriorated, original steel truss columns with galvanized assemblies.

The latest phase began in September 2022, with the \$10 million contract calling for the blast removal of lead-based paint in the upper 60 feet of the conservatory dome, cleaning and repair of the steel and aluminum glass frames, re-glazing of doublepaned laminated safety glass, and masonry work. A complex interior/exterior scaffolding system encompassing the 80-foot-tall dome (also known as the Palm House) was removed last spring.

The conservatory and Belle Isle Aquarium next door (which is also the nation's oldest) opened together and were originally designed as a single facility. "The conservatory," says the state DNR, "features an indoor display of plants from around the world, outdoor seasonal floral beds and a koi lily pond. In addition to unique horticultural and aquatic collections, the building itself is a draw for architecture and history buffs; it was designed by Albert Kahn, one of Detroit's most celebrated architects."

The conservatory's grounds today encompass 13 acres. According to the DNR, renovations on the conservatory began in 2019 with the replacement of 20 original steel trusses, many of which were rotted. "Major renovations are needed to stabilize the building to keep the conservatory open for the next century," said Amanda Treadwell, urban field planner for the DNR Parks and Recreation Division, when the latest round of work was announced in October 2022.

"Although construction will temporarily close this popular attraction, the scope of work is critical to the structural integrity of the dome, public safety and

improved conditions for the plant collection."

Treadwell said such capital improvements have been long overdue. "Besides the recent renovations in 2019, there has not been a major capital investment to the conservatory since the 1950s," she said. "The goal with this project is to address the scope of work currently identified, ensure efficiencies in construction staging and eliminate the need to close the Palm House in the future."

Among the priorities for Ideal Contracting and its subcontractors: maintaining the warm temperatures and high humidity for the towering palms and tropical plants housed in the dome, throughout construction. On warm summer days, temperature can reach 120 degrees at the top of the dome. The glass in the dome, which is slightly curved, is frosted a bit to keep temperatures down. Two new catwalks were added at the top and bottom of the structure.

The Conservatory is divided into various connected "houses." According to the Belle Isle Conservancy: The Palm House includes tropical trees and palms, the Cactus House is home to succulents and cactus, the Fernery is sunken to provide cooler conditions and more humidity, the Tropical House is where many plants that provide food are housed, including bananas, oranges, figs, and the Show House has changing displays of flowering plants.

Muer said small crews of about 12-15 tradespeople have worked on the project over the past 22 months. "They have been great, you really appreciate union trades when you've worked with nonunion," he said. "You appreciate the professionalism and safety standards of union contractors."

Another phase in improvements at the conservatory could be announced in the fall.

"I think the biggest challenge here is that nothing is straight,'

# **Court de-claws federal agencies, gives** judges new clout to rule on worker cases

(Continued from Page 1) powers, and attempt to move their cases before business-friendly judges and circuit courts. The bottom line: the 6-3 Supreme Court ruling is primed to place labor unions on the short end of the legal stick.

"For four decades, the high court's ruling in a case called Chevron v. Natural Resources Defense Council has empowered executive agencies overseeing the workplace, the environment, the stock market and other parts of American life. Under the 'Chevron deference' principle, judges must defer to agencies' reasonable interpretation of ambiguous laws," wrote attorneys Alex MacDonald and Michael Lotito for Littler, a labor and employment legal firm. "The Biden Administration has wielded 'Chevron deference' in support of unions and rank-and-file workers when deciding, for example, what counts as 'protected concerted' activity when workers push for higher wages or complain about working conditions. Without Chevron deference, judges will have more power to decide these questions, while executive agencies may be less willing to issue certain regulations in the first place." AFL-CIO President Liz Schuler and other union leaders criticized the "disheartening decision," which she termed "a huge gift" to corporate special interests. "Today, a right-wing supermajority on the Supreme Court has eroded the federal government's ability to ensure that the law is enforced and that working people are protected," Shuler said. "This ruling paves the way for corporate challenges to the actions of the Occupation-al Safety and Health Administration, the National Labor Relations Board, and other agencies with a duty to protect workers' lives and rights, which would allow employers to get away with retaliation, unionbusting and maintaining dangerous workplace conditions." The Supreme Court's three liberal justices, Elena Kagan, Sonia Sotomayor and Ketanji Brown Jackson, questioned the need to overturn Chevron, which has historically moved interpretation of vague federal laws to experts at various federal agencies. And in the federal government, the major concern for organized labor will be the future interpretation of two federal laws

outdated and potentially ambiguous language that were put on the books generations ago: the National Labor Relations Act of 1935, which protects workers' right to organize; and the Federal Labor Standards Act of 1938, which created the minimum wage, the 40-hour work week and banned child labor.

that offer all manner of vague, interpreting those laws, especially when it comes to cases with under-represented workers vs. legally powerful corporations.

"If you think about the backgrounds of federal judges, relatively few of them have much experience with labor unions or even low-paid jobs," University of Minnesota law professor Charlotte Garden told the Minnesota The limited expertise of Reformer. "On balance, getting rid of Chevron deference will be worse for workers ... even though we'll probably be able to point to some examples where it's been good."

Muer said "And when you go to open something up, you're thinking, I don't know what's behind it, but I know that it's rotted. There have been a number of areas of rot that we have been unaware of." That's not too surprising, given the age of the structure, its placement in the middle of an island in the Detroit River, and the constant assault by wind, rain and temperature extremes.

According to the Detroit Historical Society, construction on the conservatory began in 1902, with many of the structure's elements inspired by Thomas Jefferson's Monticello home. The building was originally constructed with glass and a wooden frame, but the wooden frame was replaced with a frame made of steel and aluminum in 1949.

In 1955, "the conservatory was dedicated to Anna Scripps Whitcomb, who donated her rare and extensive orchid collection, the historical society said. "Her collection contained 600 rare orchids, many rescued from Britain during World War II. Thanks to her donation, the City of Detroit became home to one of the largest municipally owned orchid collections in the United States.'

"With its huge, exquisitely proportioned central dome, flanked by symmetrical wings, the conservatory typifies the lofty idealism of the City Beautiful Movement at the turn of the century," says the American Institute of Architects Guide to Detroit *Architecture.*



# **BUILDING MICHIGAN:** Salty Manistee HISTORY IN THE MAKING By Marty Mulcah

MANISTEE'S MORTON SALT CO. works is shown in a 1940s postcard. Then and now one of the city's largest employers, brine has been extracted at the site since salt was discovered nearly2,000 feet below ground. Chicago-based Morton Salt took over the company in 1930, and has operated it ever since.



Enter an apparel shop in one of our state's beach towns this summer, and you're likely to find a baseball cap or shirt that humorously boasts that Michigan and our Great Lakes are shark- and salt-free.

And that's true, at least regarding the ocean predators and salinity in the lakes. But dig a couple thousand feet below the surface of much of Michigan's Lower Peninsula, and that salt-free proposition kind of falls apart, like so many salt granules. (Not that anyone is going to argue with the wearer of a t-shirt).

Michigan actually has an unfathomable repository of salt underground – estimated at 71 trillion tons, in an area that covers nearly the entire mitten portion of our state roughly north of I-94. And since the 1860s, mining, processing and transporting that salt has been, and continues to be, a significant industry. So much so that Manistee was once known as the nation's "salt city," and a mine near that Lake Michigan town continues to produce the white stuff today for the Morton Salt Co.

"The salt industry of Manistee can be attributed to the tenacity of lumberman Charles Reitz, who throughout the 1870s was a partner in the Reitz Brothers sawmill firm," wrote Mark Fedder in a 2016 article on the regional history of salt for the Manistee News Advocate. "In 1879, state geologist Dr. C. Rominger arrived in Manistee and stated to local officials that he believed there was a large vein of salt underneath the town. After chatting with Rominger, Reitz became convinced of the salt deposits and decided to drill for salt. Following a large investment and many months of work, salt was struck in the spring of 1880 at a depth of nearly 2,000 feet." Thus Manistee, already a booming lumber town, became an even larger manufacturing port city with the rise of the salt industry. "Eleven other lumbering companies followed Charles Rietz's example like a flock of sheep," wrote K.E. Childs in his paper, the *History* of the Salt, Brine and Paper Industries and their Probable Effect on the Groundwater Quality in the Manistee Lake Area of Michigan. There are various ways to mine salt, and Manistee's deposits have always used the evaporation process. Air, water and steam are piped down to mix with the salt deposits, and ultimately a brine is pumped up and evaporated to create a granular salt that could be packaged and shipped to ports on the Great Lakes and beyond. Other sawmill operators in the region, Fedder wrote, saw the same profit potential, and they

drilled for salt on their own properties, using waste wood as fuel to power the pumps and the machinery needed to evaporate the brine.

"Over the course of the next several decades," Fedder wrote, "Manistee was often called, 'The Salt City of the Inland Seas' and by the late 1890s was producing over 1 million barrels of salt a year. The town was also became a popular destination for people suffering from various health ailments, including rheumatory arthritis, as both The Manistee Salt & Mineral Bath Co. (later The **Briny Inn) and Mercy Hospital** offered medicinal salt baths."

According to the Man*istee Daily Advocate*, at the time those salt baths were thought to be "an invigorating indulgence to any system; it stimulates the circulation, arouses the torpid and sluggish secretions, elimi-

Daily Advocate said. Today, the Morton Salt Co. has 20 production facilities across the U.S., Canada and the Bahamas, including its works in Manistee, at Fifth and Kosciusko streets. It's the company's only location in Michigan, although it does have a plant in Windsor, Ont.

Regarding the salt production process in Manistee, according to Morton: "At our evaporation sites, water is pumped into an underground salt deposit. The salt dissolves, and is pumped back to the surface as saturated brine, which is boiled in a series of vacuum pans. Salt crystals fall to the bottom of the pan as a slurry and is then dried and packaged. Salt from our evaporation sites is used for various products for consumer and industrial use, such as culinary salts and water softening salts." Morton Salt said its site "historically had five wells in a 20-acre tract... averaging about 2,000 feet deep." According to the Michigan State University's Department of Geography, "during the Paleozoic Era, beginning about 600 million years ago and ending about 230 million years ago, seawater invaded the Michigan Basin at least six times. As the seas receded and evaporated, rock and mineral deposits such as halite (rock salt), gypsum (calcium sulfate with water), liquid brines, petroleum, lime, clay, sandstone and coal were left behind. MSU said the Manistee salt deposit is among the state's thickest, running in a narrow, 400-foot-deep band extending northeast to Presque Isle Co. A similar 400-foot fat band of salt lies under the middle of the state, centered roughly in Clare Co. The salt deposits under Michigan also extend under most of Ohio, half of Pennsylvania, the state of New York along Lakes Erie and Ontario and beneath the eastern portion of the province of Ontario, making the region one the top five largest salt deposits in North America. From 1880 until 1892, Michigan led the nation in salt production, competing with New York for top spot through the 1920s. Today, according to the U.S. Geological Survey, Michigan perennially is one of the top seven states in salt production, and those seven states (Kansas, Louisiana, Michigan, New York, Ohio, Texas, and Utah) produce 95 percent of all the nation's salt output. Michigan salt mines (there are nine brine mines and one dry mine) produce 3 million tons of salt per year.

# **OSHA** keeps regulatory powers, but future role is clouded by Supreme Court

(Continued from Page 1) such powers in congressional hands.

Justice Thomas agreed with Allstates, in a written dissent from the court's decision not to take the case. He also said Justice Neil Gorsuch, the intellectual force behind overthrowing Chevron, agreed, too. Gorsuch didn't write anything. And the two couldn't recruit two more justices to join them and agree to hear the Allstates case.

"Congress purported to empower an administrative agency to impose whatever workplacesafety standards it deems 'appropriate," Thomas wrote. "That power extends to virtually every business in the United States. The agency claims authority to regulate everything from a power lawnmower's design to the level of 'contact between trainers and whales at SeaWorld.'

"If this far-reaching grant of authority does not impermissibly confer legislative power on an agency, it is hard to imagine what would.'

With the Justice Department representing OSHA, Su's DOL was left to argue against *Allstates* alone.

Allstates "seeks to invalidate a statutory provision enacted more than 50 years ago" which "has been the basis for the issuance of numerous safety standards that greatly reduced occupational injuries and deaths over that time," said Su's brief urging the justices not to take the case - a denial decision all but Thomas, and probably Gorsuch, agreed with.

The Constitution "vests the 'legislative powers' to Congress, Su's brief elaborated. "Although Congress may not delegate legislative powers to the executive"in this case, the Labor Department and OSHA, which is part of it – "it may seek the executive's 'assistance' by vesting discretion in (executive) officers to make public regulations interpreting a statute and directing details of its execution.

"If a statute sets forth an 'intelligible principle to which the person or body authorized to

(act) is directed to conform,' it's a permissible grant of implementing authority to the executive rather than a forbidden delegation of legislative power."

Responding to the case, the National Association of Safety Professionals said: "The Supreme Court's decision to decline the case preserves the status quo, allowing OSHA to continue setting and enforcing workplace safety standards. However, the ongoing debate over the constitutionality of such delegations suggests that future challenges could arise, potentially impacting the stability of current workplace safety regulations. For now, OSHA's authority remains intact, ensuring continued protection for workers across various industries."

# Unions cheer start of heat protection rule

Las Vegas, 111 degrees. Above-normal temperatures also are expected for much of the country in July, especially in central and eastern United States," the president said.

"I think it's going to surprise a lot of people...heat is the No. 1 weather-related killer in the United States," he told a crowd of Labor Department workers and invited guests.

Biden's Labor Department said its "proposed rule would require employers to develop an injury and illness prevention plan to control heat hazards in workplaces affected by excessive heat.'

The DOL would require employers to evaluate heat risks to workers. When risk rises, they must "implement requirements for drinking water, rest breaks and control of indoor heat. It would also require a plan to protect new or returning workers unaccustomed to working in high heat conditions."

The view is different, however, on the other side of the political aisle.

Brushing aside opposition from the state AFL-CIO, Texas's Republican-gerrymandered legislature passed and GOP Gov. Greg Abbott signed a ban on businesses offering workers anti-heat protection, even banning extra water.

Their law, which took effect last September, also bans Texas cities and counties from enacting heat protection ordinances - overturning the Dallas and Austin ordinances which mandated ten-minute water breaks for outdoor workers every four hours.

The House's ruling Republicans, represented by anti-worker Education and the Workforce Committee Chair Virginia Foxx of North Carolina, squawked that Biden's "one-size-fits-all" rule would harm 'job creators" - their characterization of businesses - and benefit the GOP's punching bag, "Big Labor."

nates the poisonous impurities that produce disease and control their formation."

Of course, while those medical claims are certainly dubious, salt has been useful in countless ways, as a food preservative before refrigeration, as a tasty flavoring for pretzels and potato chips, and as an icemelter on streets and sidewalks.

Manistee began to decline as a hub for the lumber trade in the 1890s. As area sawmills closed, so did the related salt industries. But it was still a significant industry: in 1893 the annual report of the Michigan "Salt Inspector" said there were 109-salt related firms statewide, producing 5.4 million barrels of salt per year. By 1898, estimated salt production in the state was 435 million tons. Most salt production was then located in mid-Michigan, and didn't include the 1,500acre mine under southwest Detroit, which opened in 1910.

By the 1910s, many salt operations in Manistee began to cease operations. Although, in 1922, the Ruggles and Rademaker Salt Co. opened a large salt factory on the former property of the Buckley and Douglas sawmill on Fifth Street. In 1930, the factory went up for auction and was purchased by







Attention All Mechanics, when filling out Probationary Apprentices OJTs, give them an honest evaluation, if you are having issues with them, state it on the OJTs. They will be evaluated at the JAC meeting, and if necessary, bring them in to try and correct any issues.

Attention All Apprentices, if you are scheduled to sit for the Mechanic's exam, you must fill out your OJTs till you get your passing results. work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each member's name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAY-OFFS: All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list 14 days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven (7) days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register biannually: March 1 through March 20 and September 1 through Sept. 20. If you fail to re-register you will be removed from the list.

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the beginning or the end of a layoff. You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.







Shuler said: "Ask yourself: 'Does this Project 2025 agenda make my life better? Would it better if these Project 2025 extremists eliminate my union? Would it be better when they take away my ability to bargain a fair contract? Or go on strike? Will my life be better when Donald Trump lets my company force me to work without overtime pay? And will my life be better when they gut the ACA and rip away affordable health care?

"Or when they end Social Security and Medicare as we know

from prosecution to threaten our freedoms and allow billionaire donors to loot America even more," PCCC warns.

Trump left a four-year legacy of anti-worker policies. He stacked the National Labor Relations Board majority with anti-worker ideologues. He also named as the NLRB's top enforcement officer, Peter Robb, a corporate-side labor lawyer, who later pledged to roll back worker protections enacted for the last 90 years, since the National Labor Relations Act's passage.

Trump stacked the Supreme Court with justices eager to weaken labor laws. He pledged approval of a national right-towork law. Trump's executive order establishing Industry Recognized Apprenticeship Programs (IRAPs) - basically a unionkilling system to allow employers alone to establish apprenticeship standards – was rescinded by the Biden Administration.

Workers have paid into these programs for their entire lives and J.D. Vance," the Ohio senator whom Trump named as his running mate "calls them 'the biggest roadblocks to fiscal sanity.'

"And will my life be better when Trump, Vance and these extremists hand over even more power to billionaires like Jeff Bezos and Elon Musk? That's what the Republican Party is telling us they really want to do" via Project 2025, said Shuler.

Trump has disavowed any connection to Project 2025. "I have no idea who is behind it," he wrote on social media. But no less than 140 people associated with his administration, including six of his former cabinet secretaries, and four he nominated as ambassadors, have their name on the document. His former deputy chief of staff has 20 pages of the document credited to him.

The wide-ranging document calls for elimination of more than 50,000 federal jobs, elimination of the U.S. Education Department, and placing the Federal Trade Commission, Federal Communications Commission, and Justice Department under the president's control.

It calls for an overhaul of the U.S. tax system that would include fewer tax brackets, the elimination of most deductions as well as a lower corporate tax rate. "It was designed to create an across-the-government smorgasbord of conservative policies," co-author Ken Cuccinelli told NewsNation. Democrats have blasted the plan, calling it the "most extreme platform in GOP history" and warned it will "gut democratic checks and balances."

The Progressive Change Campaign Committee warns that Project 2025 also would trash many other protections workers and the rest of the country now take for granted.

"Project 2025 is the rightwing blueprint for a second Trump presidency. It represents a takeover of all parts of our government by dangerous, powerhungry extremists – including unilateral actions by an extreme president, who now has immunity

Trump's claim to be "a dictator on day one" if re-elected stoked related fears that the Project 2025 document will provide a guide for the president.

'The MAGA right is done speaking in euphemisms, said Senate Majority Leader Chuck Schumer. "They're saying it straight to your face: If you can disagree with Donald Trump, watch your back. It's bonechilling. It's un-American."

board; we finally saw a welcome move with lower shelter price pressures (inflation coming from the housing market). We also saw favorable declines in gasoline and airfares prices."

In the construction industry, material input prices dropped for the month, but are 1.1 percent higher than a year ago, while nonresidential construction input prices are 0.7 percent higher.

"While ABC members continue to report stable backlog... and steady confidence as measured by the Construction Confidence Index, there remain reasons for concern," said Associated Builders and Contractors Chief Economist Anirban Basu. "While construction input prices fell last month... the Federal Reserve is still looking for data indicating that 2 percent inflation will soon be reestablished, so data like these may forestall much-anticipated and desired interest rate cuts."

rules cracking down on bosses misclassification of workers as "independent contractors" not covered by labor law, workers' comp or jobless benefits. Another bans NLRB from implementing its "joint employer" rule that says a corporate office and a local franchise owner are equally responsible for obeying or breaking labor law.

The GOP crowed that protecting "independent contractors" would "liberate 64 million American women, seniors, and others balancing work with family responsibilities to participate in the freelance economy," more commonly known as the gig economy.

By contrast, "adequate funding for worker protections, job training, public health and education is essential to the well-being of all working families, but the allocations for FY2025 contained in this bill are grossly inadequate, reflecting a dangerous disregard for our nation's needs," Jody Calemine, the AFL-CIO's new legislative director, wrote lawmakers.

"Specifically, the legislation slashes funding for the National Labor Relations Board (NLRB) by \$99 million, despite historic increases in union election petitions and unfair labor practice charges. It would cut funding for the Wage and Hour Division by \$25 million, the Occupational Safety and Health Administration by \$75 million, and the Mine Safety and Health Administration by 5 percent, all which would lead to a dramatic reduction in enforcement of job safety, minimum wage and overtime laws."

"As we warned, a crisis is coming in federal labor law," the NLRB Staff Union said in a recent tweet. "Election petition and unfair labor practice charge filings with the NLRB are at 15year highs, but the agency has lost nearly 40 percent of its field staff from FY2010. Enforcing the law requires civil servants."

If the Senate doesn't take those poison pills out of the bill, off past practice, then President Joe Biden will, with a veto threat, his veto pen, or both.

<u>Outdoors</u> Beach cleaning BeBot on patrol

Cigarette butts, discarded food wrappers, shards of plastic – they're all items we wish to avoid when we're at the beach and have our toes in the sand.

Thanks to new technology – a beach-cleaning robot known as "BeBot," developed by Niteko Robotics – we'll be seeing less trash at our beloved inland lake beaches and Great Lakes shorelines. Several state park beaches are now using Be-Bot, an advanced method of managing litter that's electric-powered and remote-operated.

This is good news for funfilled summer days along the water, and even better news for the environment.

With the capability to cover 32,000 square feet per hour, the robot efficiently clears away various sizes of plastic debris from the landscape including bottles, food wrappers, cigarette butts and fragmented plastic particles.

"The Michigan state parks and recreation system strives to seek out innovations that help us operate efficiently, saving time and resources while delivering quality outdoor recreation experiences to our visitors," said Ron Olson, chief of the Michigan Department of Natural Resources Parks and Recreation Division. "This innovative tool is an opportunity to improve our methods to maintain clean beaches."

**BeBot beach cleaning.** The DNR's Parks and Recreation Division purchased a BeBot in 2023 for use in southeast Michigan's Rose Lake District, which includes Brighton Recreation Area in Livingston County.

"The BeBot is a great addition to the Rose Lake District," said Rowdy Perry, unit supervisor at Brighton Recreation Area. "A lot of emphasis is placed on Great Lakes health, but inland lakes health also plays a major part in the state's overall ecosystem protections. The BeBot not only helps clean the beaches around the district, but it also serves as

a conversation starter to educate the public about the importance of clean beaches and water across the state."

Farther north, the DNR's Gaylord District is partnering with the Tip of the Mitt Watershed Council to use a BeBot for trash collection on local beaches. These include shorelines at Petoskey and Cheboygan state parks.

Also this summer, the BeBot

was deployed for the first time on Belle Isle, which the DNR has managed as a state park since 2014. This is part of the Belle Isle Conservancy's environmental campaign, Keep Belle Isle Beautiful, and the Great Lakes Plastic Cleanup, a collaborative effort between the Council of the Great Lakes Region Foundation in the U.S. and Pollution Probe in Canada, targeting enhanced

Mark Fisher, the president and CEO of the CGLR network, also talked about the value of this partnership and its contribution to a circular economy – one that keeps materials and products in circulation for as long possible by reducing material use, redesigning materials and products to be less resource-intensive and recapturing waste as a resource to manufacture new materials and products.

"The Detroit River serves a vital economic and ecological corridor between the United States and Canada," Fisher said. "By partnering with the City of Detroit and the Belle Isle Conservancy, as well as The Clorox Co. and Meijer that share our commitment to sustainability in the Great Lakes region, we are able to keep our beaches and waterways clean and free of plastic litter as we work to end plastic waste by moving to a circular economy."

Far-reaching robot. The BeBot has already proven its effectiveness in removing and studying the sources and pathways of plastic litter on Great Lakes beaches in Michigan, Ohio and Wisconsin with funding from Meijer. With cleanup efforts gaining momentum in the region, the introduction of the BeBot on Belle Isle this summer offers a unique and impactful solution to learn about and tackle the plastic litter pollution challenge facing not only the island and Detroit River, but the entire Great Lakes basin

"Meijer is proud to support the BeBot pilot program on Belle Isle Beach, which demonstrates our commitment to environmental stewardship and innovation in the Great Lakes region," said Erik Petrovskis, director of environmental compliance and sustainability at Meijer. "As a family company with a long history of serving Michigan communities, we care deeply about the health and beauty of our natural resources and the well-being of our customers and team members. We applaud the City of Detroit for their leadership and collaboration in this ground-breaking initiative to reduce plastic waste and protect our waterways."

**Continuing cleanup efforts.** The City of Detroit, the DNR and other partners will seek to secure funding in the future to expand the initiative on Belle Isle with an additional BeBot as well as a PixieDrone, a remotely operated floating waste collector that would be deployed in local waterways.

In addition to the BeBot pilot program, the City of Detroit remains committed to ongoing cleanup initiatives, in addition to the Keep Belle Isle Beautiful campaign launched in 2017.

The Belle Isle Conservancy will operate the BeBot during public cleanup events, conduct waste characterizations – determining how much paper, glass, food waste and other materials are discarded in the waste stream to help plan how to reduce waste and conserve money and resources – and collect and report metrics from findings.


