Laborers removed as OSHA advisors

The Laborers International Union, which has a very active and effective Health and Safety Fund advocating on behalf of its members and other construction workers, has seen its advisory relationship with OSHA "ended abruptly" on July 1.

That's when the federal Department of Labor issued a final new rule that removed OSHA's federal obligation to consult with the members, including the Laborers and other unions, with OSHA's Advisory Committee on Construction Safety and Health (ACCSH).

"The mandate to consult with ACCSH existed so both employer and worker representatives could take part in the regulatory process," said La-borers Health and Safety Fund Management Co-Chair David Rampone. "In an industry like construction, the real-life experience of members and contractors on the frontlines is irreplaceable."

For more than 30 years, staff at the Laborers' Health & Safety Fund of North America have advocated directly to federal OSHA on behalf of LIUNA's members and signatory contractors.

"It appears OSHA revoked this ACCSH statute to comply with the president's 'Unleashing Prosperity Through Deregulation' executive order," the Laborers reported, "which directs agencies that for each new regulation issued, at least 10 prior regulations be identified for elimination." The revised final rule on ACCSH makes reference to this, citing that "compliance with these regulations would needlessly delay the Secretary of Labor's regulatory agenda.'

Access to the OSHA committee, said Laborers General President Brent Booker, "has created a seat at the table for LIUNA members and made sure our voice gets heard."

Now that "seat at the table" has been removed.

Repair the roads, but at what cost?

LANSING - At press time, there was a Republican plan in place to fix the state's roads, and fund the rest of Michigan's government in 2026.

The GOP-controlled House on Aug. 26 adopted a \$54 billion Fiscal Year 2026 spending plan that puts \$3.4 billion in new money toward roads, which is essentially what independent estimators say is needed in Michigan as a permanent funding fix. But in the state Senate, Democrats who are in control are balking at the funding package and see a whole lot of other painful cuts that the GOP is proposing elsewhere in state government.

The GOP plan cuts \$100 million from public health, and \$2.7 billion from human services – both seen as disastrous by health professionals. The Republican budget would eliminate 4,300 state jobs, cut \$63 million from the Michigan State Police, and set a 12 percent revenue sharing cut for counties. The Department of Labor and Economic Opportunity would

see a \$1.1 billion funding loss. Two months late for the July 1 statutory deadline to set a budget, Michigan lawmakers are facing a budget settlement deadline of Oct. 1 before state government would be faced with a shutdown. The difficulty finding new money for roads, at the expense of other priorities, continues to vex lawmakers.

Helmets to Hardhats Michigan success story 'really

does restore lives' for vets

DETROIT - Military veterans are typically good fits for work in the building trades. Soldiers who have left the service are adaptable, disciplined, punctual, and are accustomed to staying on task and taking orders.

If you're wishing that the greenhorn apprentice next to you had more of those same qualities, you get a better understanding for why Helmets to Hardhats has been such a success in Michigan and around the country. The program was started 23 years ago, but in the past three years in Michigan, the number of military veterans embarking on building trade union careers has risen by 28 percent, in good part because of a state grant that allows Sam Dougherty to keep doing what he's doing on behalf of the military community.

Sam was a speaker Aug. 19 at the 53rd Convention of the Michigan Building and Construction Trades Council. A Marine Corps reservist for six years, and a Laborers Local 355 member, Dougherty now serves as Michigan state representative for Helmets to Hardhats. He told Michigan building trades delegates that the availability of

NLRB's existence hangs by a string with appeals court ruling

For nearly a century the National Labor Relations Board has been an indispensable source of justice for aggrieved workers and unions.

Administering the National Labor Relations Act, the NLRB has adjudicated and remedied

unfair labor practices, safeguarded workers' right to organize a union, conducted secret ballot elections during organizing drives, while ostensibly protecting workers' and/ or employers' rights as they

investigate charges and facilitate settlements.

But that was then. This is now – an era when workers never seem to get a break. On Aug. 19, the Fifth Circuit U.S. Court of Appeals panel took up a case brought by billionaire Elon Musk and his company, SpaceX, that sought to bar the NLRB from prosecuting

Weight of corporate pressure wins again, as 'catastrophic snap' awaits U.S. labor law

And just like that, it frees Elon Musk – and any fellow employers – to violate whatever rights their workers thought they

The National Labor Relations Act (NLRA) – that pillar of American democracy that gives workers the right to bargain collectively with their employers – was enacted 90 years ago this summer. Its constitutionality was upheld two years later by the Supreme Court, and no successful challenge to its constitutionality has been brought in the subsequent 88 years. Until last month, when the avowedly far-right Fifth Circuit decided otherwise.

Today, the NLRA hovers somewhere between de facto and de jure nullification. It's been slowly eroding for at least half a century, as employer resistance to it has heightened, and as the penalties to employers for violating its terms have weakened.

Currently, the fact that the five-member National Labor Relations Board is down to just two members – not enough to constitute a quorum – means the Board can make no rulings. This enables employers who've been found (Continued on Page 3) | to have violated workers' rights

The Republican justices are expected to soon reverse the Court's 1935 ruling in a case called Humphrey's Executor, which limited the president's power over independent regulatory agencies. By upholding Trump's firing of Wilcox and other heads of regulatory agencies, those justices have positioned themselves to rule that such limitations violate the Constitution's vesting of executive power in the

president. Last month, the Fifth Circuit Court of Appeals circumscribed the NLRB's power even more. Before the court was a suit that Elon Musk's SpaceX had filed against the Board, concerning a pending investigation from one of the Board's regional attorneys into claims that SpaceX had violated its workers' rights by firing eight of them for going online to opine that Musk's online verbal outbursts and abuses actually hurt

Michigan sees a little dip, but construction remains robust

Overall, it's still a good time for construction employment in Michigan.

The latest Bureau of Labor Statistics employment numbers, released Aug. 19, show that despite a small pullback between June and July, Michigan has continued to maintain its status

as a top-10 employer for Hardhats among the states. The BLS numbers show Michigan gained 10,100 construction workers between July 2024 and July 2025 that represents a 5.1 percent gain,

ranking us No. 9 among the states for job gain percentage during 28 states that saw construction

Trump blows down \$1.3B wind project

A \$1.3 billion ocean-based wind project under construction off the shore of Rhode Island that would provide more than 700 megawatts of power was halted Aug. 22 by the Trump Administration. Union trades have built the Revolution Wind project, which was 80 percent complete with 45 of its 65 wind turbines already in the water, according to the Danish owner, Orsted.

The Department of the Interior's Bureau of Ocean Energy Management, which issues permits for offshore wind projects, cited a Jan. 20 memo by President Trump that indefinitely pauses federal reviews on offshore wind projects. A letter from the federal agency to the project's owner cited "concerns related to the protection of national security interests of the United States and prevention of interference with reasonable uses of exclusive economic zone, the high seas, and the territorial seas."

C'mon. Fix the damn roads

It's long been said that Michigan has two seasons: winter and road construction.

That has never been more true than over the last few years, as Gov. Gretchen Whitmer's road bonding program and the Bipartisan Infrastructure Law turbocharged investments to repair and enhance Michigan's crumbling transportation infrastructure. 

AGC officials noted that private sector developers appear to be delaying or cancelling some projects amid uncertainty about construction costs and ongoing questions about future interest and tariff rates. 



BUILDING MICHIGAN: Fort St. Joseph HISTORY IN THE MAKING



FORT ST. JOSEPH in Niles doesn't exist any more. In fact, no one knew exactly where it was located until researchers from Western Michigan University solved the mystery in 1998. It was constructed by the French in 1691 more as a key post for trading and exerting its national influence than for military use. In 2010, a foundation wall and corner posts of one of the original buildings were discovered. This rendering represents an educated guess about the installation, which is listed on the National Register of Historic Places. French military engineer Sebastien Le Preste de Vauban's design used bastions, the projections at the corners of the stockade. French voyageurs and missionaries traversing what would become Michigan and other Great Lakes states in the 1600s didn't go to the trouble of building a fort without due consideration.

Forts were more than just military installations. Yes, they contained barracks for soldiers and were set up to repel invaders. But forts were also a social and religious center, containing homes and shops, while hosting the trading of goods, and acting as a permanent physical space for the French royal government to impose its influence in North America.

The French had governing authority, or at least controlling influence in Michigan for nearly 150 years until they ceded control to the British in 1763 after the French and Indian War. But the scarcity of their established forts in land that would become Michigan, illustrates how important those five installations were to French governance.

One of them, Fort St. Joseph, wasn't built in the Lake Michigan town of St. Joseph, but 25 miles southwest in Niles, just above the Indiana border. Fort St. Joseph was first established as a mission in the 1680s by French Jesuits. The land was granted Michilimackinac (built in 1715 in Mackinaw to the Jesuits by King Louis XIV, and Fort St. Joseph was constructed in 1691.

"Officially established by the French, Fort St. Joseph housed a small garrison and served as a trading post located along two significant trails, the Sauk Trail and the Grand River Trail," says a history prepared by ers say the construction of French forts in the the City of Niles. "It was also located in proximity to a portage that connected the Great Lakes watershed

with the Mississippi River. Fort St. Joseph was occupied for 90 years from 1691 to 1781. Control of the area shifted during this time from the French, to the British, to several Native groups (including the Potawatomi and Miami), and then briefly to the Spanish."

The Encyclopedia of French Cultural Heritage in North America said "Fort St. Joseph was one of the most important 18th Century frontier outposts in the western Great Lakes region. Initially established by the French as a mission in the 1680s, the site became a hub of religious, military, and commercial activity for local Native American populations and European colonial powers for nearly a century.'

The fort never saw significant military action. Prior to the French and Indian War (1756-1763) Fort St. Joseph held a tiny French garrison of 10-20 soldiers, and a commandant. It also had a blacksmith, Catholic priest, interpreter, and 15 households. When the British took control of the fort after the war, they maintained it as a center for fur trading.


"The military played a substantial role in the establishment of New France," says Western Michigan University's Fort St. Joseph Archeological Project. "They constructed fortifications for use by soldiers, fur traders, and Jesuit priests. Many were built hastily and at little cost to spread French influence and to facilitate communications throughout the area."

During the Revolutionary War, the British used the post to supply allies among the Native people against American rebels. The Spanish raided the fort in 1781, and briefly claimed it as their territory. After the new Americans won the war, western settlers eventually arrived, and thus we have Niles' nickname, "The City of Four Flags" – it is one of the rare cities in the nation that have operated under the flag of four nations.

The Fort St. Joseph Archaeological Project is an ongoing partnership between Western Michigan University, the City of Niles, Support the Fort, Inc., and other community groups. The project hosts open houses, sponsors archaeological digs and displays uncovered artifacts from the fort, which is long-gone but continues to offer researchers an opportunity to learn how the first European settlers in the area lived.

"Documentary sources indicate that the fort was constructed with entrances on the north and south palisade lines and that the palisade enclosed a small commandant's house, a building that could accommodate 20 soldiers, a military storehouse, and some buildings to store trade goods and furs," says a report by the Fort St. Joseph Archaeological Project. "In 1753, the post was estimated to consist of 15 houses, though not all of these buildings were necessarily within the palisade. The fort became an important link in the chain of similar frontier settlements that staked out the far reaches of New France and facilitated the trade between the French and Native peoples in furs.

"For almost 80 years, French priests, enlisted men and traders lived at Fort St. Joseph in close contact with Native groups also living in the area, specifically the Potowatomi and Miami. Wives (in some cases Native wives) and children of the French men, as well

> in the commercial and social functioning of the post."

> In 1781 a small contingent of French and Natives supported by the Spanish governor at St. Louis raided the fort, claiming it for Spain, though they remained at the site for only a day. Then essentially abandoned, Fort St. Joseph became overgrown and forgotten over the centuries

> "Over time the exact location of the fort was lost and the town of Niles developed around it," a history by the city said. Then in 1913, "a commemorative boulder was dedicated at the Fort's approximate location."

> It wasn't until 1998 that the fort's location was confirmed. An organization called Support the Fort, Inc. asked Dr. Michael Nassaney of Western Michigan University to search for the fort. "Dr. Nassaney was able to definitively locate the area that once contained the fort itself," said the City of Niles. "Ongoing excavation and research are revealing information about the appearance of the fort, its occupants, and their role in the fur trade and colonialism."

ACCORDING TO Western Michigan University's Fort St. Joseph Archeological Project, French fort walls were generally made with rounded or split logs placed vertically, and sunk 4-9 feet. The preferred wood was cedar or oak, but that was dependent on local forests. For the walls and interior building foundations, builders simply sunk posts or set them on stone foundations excavated into a hole or ditch up to 4 feet deep. In between the posts the walls were filled with stone and mortar ("pierrotage," depicted above) and/or a mixture of clay and straw ("bousillage"). Michigan success story 'really does restore lives' for vets

- especially when it comes to a veteran looking for employment. Helmets to Hardhats was created in 2003 by the nonprofit Center for Military Recruitment, Assessment and Veterans Employment. H2H is a nonprofit joint labormanagement driven entity that connects transitioning active-duty military service members, veterans, National Guard members and reservists with skilled training and quality career opportunities in the construction industry.

Since 2003, the group says nationally they have helped close to 50,000 military personnel successfully transfer into civilian careers in the construction trades.

Since a state Labor and Economic Opportunity grant was made available about twoand-a-half years ago, allowing Michigan to have a full-time H2H director in the person of Dougherty, he said interest in the program has increased 300 percent. About 2,700 veterans have since visited the group's website, created profiles, and have been exposed to the trades during outreach programs as a valuable option for a career.

Michigan, Dougherty said, is one of only three states with a dedicated director funded by a state grant, and is about fourth in the nation when it comes to Helmets to Hardhats participation. H2H has partnered with all 15 building trades international unions, who the group said, "have made a commitment to help our military heroes successfully transition to civilian life and work. Through these partnerships, Helmets to Hardhats connects transitioning military members with fulfilling, familysustaining, middle-class careers in the construction industry via gold-standard, earn-while-youlearn registered apprenticeship programs.

"We connect participants with employers as well as educate them on how to use their G.I. Bill benefits to supplement their income while completing their training."

The first step for veterans considering employment in the

building trades starts with a visit to www.helmetstohardhats.org. Vets can input their military occupational specialty, create a profile, learn about career opportunities, then will receive an automatic email from Sam with his contact information.

Noting the hightened mental health issues and suicide rates among veterans, Dougherty told delegates that shortly after he started his position he discovered that H2H "is the answer to so many things needed for the transition of veterans. I truly believe that the veterans that I talk to here in Michigan have jobs because of you, your locals, that we truly are saving lives, we're restoring families, we're breaking the cycle. These are Michigan residents who are coming into the trades, and that's a great thing, because the structure that we're used to as veterans, the structure works, the brotherhood, the sisterhood, and it really does restore lives."

NLRB's existence now in doubt with appeals court ruling

very structure likely violates the United States Constitution." The 3-0 appellate court ruling was made by three Republican-

appointed judges. In this case, arguments by Musk and other employers responding to worker complaints basically looked at the complaints and said instead of arguing over this, let's just blow up the system.

The argument by Musk and the other employers centered on the president's limited ability to remove any of the five members of the NLRB and the board's administrative law judges. They argued that the National Labor Relations Act only allows the president to fire board members for "neglect of duty or malfeasance in office," and can only remove ALJs for "good cause." SpaceX and others "argued this double-layer of job security improperly ties the president's hands," Billington said. "The Fifth Circuit majority agreed."

Wrote Judge Don Willett, an appointee of President Donald Trump, in agreeing with Musk and the others: "Because the executive power remains solely vested in the president, those who exercise it on his behalf must remain subject to his oversight."

The five-member board has basically been paralyzed and unable to issue decisions during the Trump Administration, since he fired member Gwynne Wilcox in January. That firing, which was upheld by the U.S. Supreme Court in May, left the board with only two members, and without a quorum. The AFL-CIO said the Supreme Court's decision to allow President Trump to fire Wilcox "is a gift to union-busting CEOs and a slap in the face of every worker."

Now what? The case will certainly go to the U.S. Supreme Court, where it's almost a cinch to be upheld by the conservative majority. Indeed, Judge Willett pointed to the Trump Justice Department, which declined to defend the NLRB's fired administrative law judges on March 5, and which will almost certainly decline to defend this case before the Supremes.

When it comes to workplace law, the ruling does indeed blow up 90 years of labor law stemming from the 1935 adoption of the National Labor Relations Act. But the ruling could prove to be a workplace wild card, setting workers free from a corporate-created obstacle course that allows employers to use the existing system to delay and deny worker complaints as well as union organizing cases.

Without an NLRB as the first place for workers to take their case, that leaves the court system, which will place cases before judges who won't have the benefit of NLRB fact-finding and who will likely have little experience with the nuances of workplace dispute resolution.

You and your health . . .



WHILE CURRENT HEALTH-CARE news highlights threats to Medicaid, Medicare and an across-the-board healthcare affordability crisis, it's important to remember that we've faced challenges before, complete with setbacks, detours and defeats along the way.

Over time, multiple generations have worked on the issue of healthcare until we've come to today's patchwork of a system. We keep struggling to make it work better, and we trust that generations to come will continue that work.

Here's an example worth remembering.

Back in 1943, Michigan Congressman John Dingell Sr. sponsored a bill to create a system of national health insurance funded by a payroll tax. Dingell's bill sought to do for American healthcare what the Social Security Act of 1935 had successfully done for the nation's elderly: harness revenues to ensure dignity for hard working Americans, this time, by providing healthcare for all.

Labor supported the John Dingell Sr. bill in 1943, and when it was killed by insurance companies, physician organizations and the pharmaceutical industry, unions didn't stop searching for ways to protect their members' health.

National Healthcare Detour

A different path presented itself during World War II. Employers and unions were incentivized to provide health insurance benefits to workers instead of wage increases. A healthcare benefit would provide something of value to workers without fueling inflation. That move laid the groundwork for today's system of employer-sponsored healthcareone that quickly became the main way most Americans receive cov-

But the idea of a national health plan wasn't obsolete or forgotten.

Every Generation Has To Win It Again

Some of the most important milestones in U.S. healthcare came about because labor and progressive movements refused to back down.

Healthcare Progress

The bill that John Dingell Sr. sponsored in 1943 didn't survive the relentless opposition from groups that stood to profit from the private system, but that didn't stop John Dingell Jr. - who replaced his dad in Congress in 1955 - from working with a broad coalition of labor and progressive social groups to achieve many healthcare victories.

Some of the most important milestones in U.S. healthcare-Medicare in 1965, the Children's Health Insurance Program (CHIP), the Affordable Care Act (ACA), and even the expansion of the National Institutes of Health-came about because labor and progressive movements refused to back down. None of these programs has ever been perfect, which is why the push for something better must continue.

AEPC: Labor Has A Say

We are proud of AEPC's labor roots, and the trailblazing work that local labor leaders such as Phil Schloop of the Operating Engineers did in the 1980s and 90s to ensure that prescription drug and health care benefits could be affordable and of high quality for union groups.

When Phil started the process that eventually became AEPC, it wasn't at all assured that it would be a success. But succeed it did, and we are inspired by those who continue to step up, often doing invisible and thankless work. We appreciate you.

Facing Tomorrow

Today's healthcare landscape is troubling. Cuts to Medicaid and

Medicare won't just hurt the most vulnerable-they'll also drive-up costs for everyone with employ-

er-sponsored insurance.

People who lose these public safety net plans won't stop getting sick. It just means many will delay treatment until their health problems become serious. By then, care is far more expensive, and those costs ripple through the entire system-showing up as higher premiums, higher hospital bills, and higher prices for all of

What do we do? Take a lesson from the Dingell father and son team that never gave up on healthcare reform. We keep at it.

Fighting for healthcare rights and other labor movement goals is not easy work. And this isn't the kind of work that moves in a straight line toward victory.

There's a labor song from the 1960s called "Pass It On" and its lyrics call on every generation to protect the gains that have been made and struggle for more:

Corporations win again, as 'catastrophic snap'awaits labor law

SpaceX had sought an immediate injunction overturning the Board's right to investigate those charges, saying that it inflicted "irreparable harm" on the company, even though it was the fired workers who suffered harm and even though the only entity inflicting irreparable harm on Musk's companies has been Musk himself, through the very outbursts and bigoted behavior that his employees had warned against. (See, e.g., Musk's effect on Tesla sales.)

In seeking SpaceX's injunction to stop any investigation the Board might order, its attorneys, from the union-busting firm of Morgan Lewis, based their claim on the argument that the Board itself was unconstitutional, since it had been established, and had been operating for the past 90 years, as an agency that the president couldn't completely control. The two Trump-appointed judges and the one George H.W. Bush-appointed judge who heard the case found for SpaceX, in a ruling that will now extend to any and every case brought against the NLRB or against employers or unions that the NLRB would adjudicate in the Fifth Circuit, which encompasses Louisiana, Mississippi, and Texas.

And in this era of judge shopping, mega-companies that may have one part-time employee or a single post office box in one of those states "may now flood the Fifth Circuit" to avoid any enforcement of decisions upholding workers' rights, former NLRB general counsel Jennifer Abruzzo told me in the wake of the court's ruling.

The neutering or repeal of the NLRA has been in the works for several years. Both Musk and his fellow world's-richest-human competitor, Jeff Bezos, had initiated lawsuits last year claiming that the act – the only act that gives workers the power to bargain with their employers and seek remedies when those employers violate labor laws – was unconstitutional.

Even before then, Musk had publicly proclaimed that he was "opposed to the idea of unions." And just as Musk's SpaceX had contested an NLRB finding by seeking an injunction against it premised on the act's unconstitutionality, so Bezos's Amazon had filed a similar lawsuit seeking a similar injunction on similar grounds. In the Amazon case, the company was opposed not only by the NLRB but by the union of the affected workers, the Teamsters. (That case is still in the works.

The SpaceX workers neither had a union affiliation nor were seeking one, so the only parties to the case were the company and the agency.

But the NLRB is now inert at the top, and has an acting general counsel put there by Trump. Trump's nominee for permanent general counsel, Crystal Carey - a former partner at Morgan Lewis, the firm representing SpaceX in this case – was asked by Bernie Sanders in her Senate confirmation hearing last month whether she believed the NLRB was constitutional. That, she answered, was up to the courts, declining to say whether she herself believed it was, and raising the possibility, verging on probability, that she wouldn't have the agency oppose the argument that SpaceX was making. As of now, Carey remains unconfirmed, as her over-the-top support for employer rule over workers alienated at least one Republican member of the Senate committee.

The Fifth Circuit could have ruled that it was the act's language forbidding presidents to make at-will firings that was unconstitutional. But by going beyond that to flatly declare that the Board itself was unconstitutional, it completely blocked workers from any attempts to have the act's protection of their rights upheld by, or even heard by, federal courts in those three states. By granting that immediate injunction, it nullified the NLRB attorneys' power to simply investigate allegations.

Abruzzo, whose service as NLRB general counsel during Biden's presidency ranks as the most brilliantly pro-worker tenure of any federal official since Sen. Robert Wagner, the NLRA's author, has some ideas about what can be done if the NLRB remains deactivated or is abolished altogether. "States have to step in," she told me, "if the NLRB is no longer functioning." Already, some states have enacted laws banning employers from compelling their employees to listen to anti-union propaganda. Many have extended bargaining rights to workers excluded from the protections of the NLRA.

But if the NLRB is no longer functioning and, for instance, can no longer hold union affiliation elections for a company's workers, then states should consider holding such elections, she suggested. And even if the NLRA is struck down in toto (as a whole) she noted, workers would still retain their fundamental right to recourse. The years immediately preceding its 1935 enactment, she recalled, were filled with boycotts, strikes, and even general strikes that closed cities down. Workers will "still have the power to withhold their labor," she said.

For now, it's important to remember that the federal assault on workers' rights isn't all Trump's doing, or Musk's, or Bezos's. Republican officials and American CEOs and mega-investors have been opposed to workers' rights and power for a very long time, just as many Democrats – not a lot, but enough to make a difference – have been lax in defending them. Today, the bough has been bent to the point that it's almost broken. A catastrophic snap may come soon.

it is: President Donald Trump just fired 1,000 of our members who had already labored to complete 80 percent of this major energy project," said North America's **Building Trades Unions President** Sean McGarvey. "A 'stop-work order' is the fancy bureaucratic term, but it means one thing: throwing skilled American workers off the job after they've spent a decade training, building, and delivering.

"And with the stroke of a pen late on a Friday, President Trump personally signed off on killing these jobs and creating chaos. He pulled the plug on an almost-finished project, taking jobs, paychecks, and food off the tables of working families in Connecticut and Rhode Island.

'The ripple effects of this decision will be felt across the entire country. Projects and industries nationwide are frozen by inconsistent rhetoric and direct actions from this Administration."

Trump has long complained about the visual appearance and bird-killing potential of on- and off-shore wind turbines. The closest turbines to the coast in the Revolution Wind project are sited

Said Laborers International Union President Brent Booker: "Workers who had good familysupporting union jobs on Friday are out of work today due to chaotic, reckless and senseless action by the Trump Administration. Many of these workers supported the president. They believed his promises of permitting reform that would

unlock good jobs and Americanmade energy. They believed his promise to bring down the cost of living. They have been betrayed.

Workers have already performed 2 million work hours on the \$1.3 billion Revolution Wind energy project. The project has already undergone a rigorous permitting process. The impact is deep and far - investors are not

likely to invest and create jobs in the future when the whims of a president can undermine their billions of dollars."

On a smaller scale, Trump's job-killing action is reminiscent of an executive order by President Joe Biden, who similarly enraged the building trades by revoking a federal permit for the \$6.9 billion Keystone XL pipeline in 2021.

Plumbing Law Changes: Starting March 20, 2025, anyone performing plumbing work in Michigan must either be registered and in good standing with the State as a plumbing apprentice or hold a current journeyman or master plumbing license. The new legislation also establishes a ratio of one journeyman for every two apprentices, with significant penalties, including steep fines and the suspension or revocation of a plumbing contractor's license for non-compliance.

This is excellent news for our industry and presents a great opportunity to expand our market share in West Michigan. Make sure that your license or apprentice registration is up to date with the State. If your license has expired or you need to register as an apprentice, you must contact the State Licensing Division at 517-241-9316.

Contract Ratification: At the special-called meeting on July 1, the members voted to accept the bargaining committee's recommendation and ratify the new three-year collective bargaining agreement. The new agreement is as follows: 1st year \$4.20/2nd year \$3.30/3rd year \$3.30/ \$10.80 over 3 years.

Language changes:

Section 13.2 - reduces the number from issuing orders from 4 to 2 to receive foremen pay.

Section 10.2 - Health care will be on hours paid not hours worked. *The contractors will now be administering the ESTA benefit.

Organizing Update: I appreciate the continued emails, phone calls, and text messages about unrepresented workers - this is a team effort. If their experience is minimal or none at all, they will have to apply for the apprenticeship application process in February. 



Michigan Sugar in Bay City. Clements Electric's Clements Electric has new work at Mersen USA, where they have also recently been awarded a maintenance contract at Mersen. Work on the Midland Center for the Arts, and Dow Gardens Welcome Center continues. Summer work includes a small raceway project in Michigan Sugar and a fire alarm project at Bangor Schools, as well as work at Bay County Health Facility about to kick off.

The lawsuit claimed that Locals in a current CBA could not participate in the ESTA benefits until their CBA expired. An appeal of this ruling has unfortunately been filed. What do you picture when you think of a forest?

Big, tall trees that have been growing for 100 years, lots of animals and birds and insects roaming and flitting around?

Think a little smaller - actually, a lot smaller – in a more urban area and a great deal more concentrated. These are micro forests.

Microforests, also known as Miyawaki forests, were developed in the 1970s by Akiro Miyawaki, a Japanese botanist and ecologist who was inspired by Japan's sacred forests to develop a new, small-scale method of forest building.

These forests are planted in urban areas and mimic the forest layers and biodiversity of much larger forests.

They can help absorb carbon to counteract climate change, remove pollutants from the air and improve the health of the people who live near them. They also are hotspots for insects and small animals in urban spaces.

Microforests can grow more than three feet per year and begin to resemble a regular forest in as little as three years because they are planted at a density of 20 to 30 times higher than a typical forest.

Asking the experts. To learn more about these forests, I reached out to Lawrence Law, an urban and community forester with the Michigan Department of Natural Resources, and Marilyn Trent from the Rochester Pollinators. The group recently led an effort to plant a microforest in their Oakland County community.

Biodiversity – using lots of different species of plants and trees – is key in micro forests, according to Law. "These micro forests have a shotgun approach to trees in a community rather than precise plantings that most communities usually do," Law said. "Having multiple species is meant to provide the most benefit to local wildlife possible and cre-

ate support between species that happens naturally in nature."

Micro forests are usually planted in parks or spaces that see little use to enhance the urban landscape. Law said they are a great source of air and water filtration. They have all the benefits of regular tree plantings, but with the bonus of quick growth and community involvement.

Instead of planting large trees in burlap or containers, micro forests often are planted with small, bare-root seedlings, which are easier to plant for senior citizens and children, helping to provide an engaging activity that can bring an entire community


"Plus, by design, those community members get to see the impact of their work since the micro forests grow faster than traditional, singular tree planting," Law said. "Being able to visually see progress in a short amount of time helps foster a sense of importance and pride in community trees and the work that goes into it."

So far in Michigan, Muskegon, Detroit and Rochester all

have their own micro forests. Warren and Sterling Heights will soon join the list.

Moving parts. Trent said the main inspirations for the microforest project in Rochester came from Green Communities Canada, the "Wood Wide Web."

These resources helped Trent

see the forest as a living, interconnected system, which she wanted to bring into Rochester's urban environment. Trent said that putting together a project like this has a lot of moving parts. She worked closely with the City of Rochester's Public Works and Parks Department.

They selected a vacant parcel of land that used to be a garbage dump. The city's public works department excavated 4.5 feet of contaminated soil and replaced it to help support plantings of mycorrhizal fungi that helps trees grow strong and resilient.

Trent also was able to secure grants from First State Bank and the Community Foundation of Greater Rochester to fund the purchase of native trees, shrubs and soil.

A lot of people were involved in this project, including Rochester Pollinators, City of Rochester Department of Public Works and Parks Department, the Rochester City Beautiful Commission and the Rochester Tree Committee.

"This project has truly taken on a life of its own. Our miniforest has sparked community engagement far beyond what we expected – drawing in young children, students, neighbors, volunteers and city leaders," Trent said. "People want to be part of it. They want to see it grow."

At a recent Community Outlook Breakfast, leaders from Rochester, Rochester Hills, Oakland Township and Rochester Community Schools shared updates on recent projects.

Nancy Salvia, mayor of Rochester, spoke about the microforest project with pride. Four other communities have reached out to Trent so far about planting their own microforests, and the City of Rochester wants to plant another one next year.

Key to the microforest.

Planting a wide variety of taller and shorter trees, as well as shrubs, is key to packing the forest full of life.

The Detroit microforest is located at Jayne Lasky Park, which is also home to a mini golf course, a recreation center, a splash pad and soccer fields.

The park's microforest contains an overstory (the tallest forest trees) of several types of oak, maple and hickory, among others and a subcanopy (middle forest layer) that includes juneberry, basswood, elm, dogwood, ironwood and maple and shrubs including spicebush, elderberry, choke cherry and witch-hazel.

The biological idea of a microforest really is about creating an ecological hotspot, space for native plants, animals and insects and helping to clear pollutants and carbon from the air.

The community aspect of microforests has grown over time, and Law and Trent have helped demonstrate the tremendous importance of community growth alongside plant growth.

Michigan has stocked 18.9 million fish in 2025

spring and summer, the Michigan Department of Natural Resources stocked a total of 18,958,970 fish that weighed more than 331.5 tons and consisted of 10 different species and one hybrid.

Fish stocking is an important activity to provide both Michigan residents and visitors with quality fishing opportunities. These efforts help bring an estimated \$3.9 billion into the state's economy through the sportfishing industry, tourism and related businesses.

To complete the task of stocking, it took 417 stocking trips and 2,345 hours. Crews traveled just over 91,000 miles in 17 specialized stocking trucks to get to the 716 stocking sites. Despite

Spring and summer fish the severe ice storm that affected stocking bring fall fishing! This northern Michigan, which caused a loss of power and transition to backup power for several days at Oden State Fish Hatchery, no fish were lost due to the storm, allowing the DNR to meet its stocking goals.

> "We had another excellent spring and summer stocking season that will bring ecological benefits and fishing opportunities to Michigan anglers," said Aaron Switzer, DNR fish production manager. Fish are reared in Michigan's state fish hatcheries anywhere from one to 18 months before they are stocked.

> In Michigan, there are six state hatcheries and two cooperative hatcheries that work together to produce the species, strain and size of fish needed for fisheries managers.
